<u>SB-2940, SD2</u> (<u>SSCR2617)</u> Status

RELATING TO TECHNOLOGY TRANSFER AT THE UNIVERSITY OF HAWAII.

Clarifies that certain sections of the State Ethics Code shall not apply to technology transfer activities; provided that the activities comply with the regulatory framework and research compliance program approved by the board of regents. Requires the board of regents to submit a written status report to the legislature every two years. (SD2)
