RELATING TO AFTER-SCHOOL PROGRAMS.

Establishes the R.E.A.C.H (resources for enrichment, athletics, culture, and health) program in the office of youth services to provide a standardized framework and funding for after-school programs in public middle and intermediate schools. Authorizes participating

schools to collect fees.
