<u>SB 2100, SD2</u> ( <u>SSCR2766)</u> <u>Status</u>	RELATING TO DISTRICT JUDGES. Increases the number of district judges in the second judicial circuit by one. (SD2)	'JUD, FIN

Establishes the law enforcement officer independent review board within the department of the attorney general to investigate incidents of officer-involved death or serious bodily injury. <u>SB 2856</u> (SSCR2630)	RELATING TO CONSUMER PROTECTION. Clarifies scope of Office of Consumer Protection investigator powers.	JUD
<u>Status</u> <u>SB 3024, SD1</u> ( <u>SSCR2648)</u> <u>Status</u>	RELATING TO THE STATE ETHICS COMMISSION. Reduces the appropriation in Act 151, SLH 2015, to the state ethics commission for an electronic filing system. Establishes a task force to examine the State's lobbyist laws and make recommendations to the legislature to amend these laws, if necessary. Re-appropriates the savings for an electronic filing system to cover the expenses of the lobbyist law task force. Takes effect on 1/7/2059. (SD1)	JUD, FIN
<u>SB 2924, SD2</u> ( <u>SSCR2796)</u> <u>Status</u>	RELATING TO THE DISCLOSURE OF TAX RETURN INFORMATION. Amends section 231-18, Hawaii Revised Statutes, to allow disclosure of tax return information to the Department of the Attorney General, federal, state, or local officials, and other persons in specified situations; and amends section 235-116, Hawaii Revised Statutes, to clarify that all information filed under chapter 235, Hawaii Revised Statutes, with any state agency is confidential. Takes effect on 1/7/2059. (SD2)	JUD, FIN
<u>SB 2926, SD1</u> ( <u>SSCR2653)</u> <u>Status</u>	RELATING TO ADMINISTRATIVE TAX APPEALS AND DISPUTE RESOLUTION PROGRAM. Changes the title of the appeals officer from independent appeals officer to administrative appeals officer. Makes a taxpayer or return preparer eligible to petition to participate in the administrative appeals and dispute resolution program and establishes conditions, procedures, and deadlines whereby the taxpayer or return preparer may petition to do so. Takes effect on 1/7/2059. (SD1)	JUD, FIN
<u>SB 2032, SD1</u> ( <u>SSCR2002)</u> <u>Status</u>	RELATING TO CAMPAIGN SPENDING. Clarifies: (1) the due dates of preliminary, final, and supplemental reports to be submitted to the campaign spending commission; and (2) that the supplemental report due on January 31 must be filed every year.	JUD, FIN
<u>SB 2030, SD1</u> ( <u>SSCR2509)</u> <u>Status</u>	RELATING TO CAMPAIGN SPENDING. Specifies certain types of dissemination, distribution, republication, and use of campaign materials, the financing of which by any person shall not be considered a contribution to a candidate. Effective January 7, 2059. (SD1)	JUD, FIN
<u>SB 2438, SD2</u> ( <u>SSCR2695)</u> <u>Status</u>	RELATING TO CAMPAIGN FINANCE. Replaces the Hawaii election campaign fund with the general revenues of the State as the funding source for the operating expenses of the campaign spending commission. Appropriates moneys to the commission for operating expenses. (SD2)	JUD, FIN
