Ensures the timely administration of mental health examinations; supports the process of expedient administration of justice; and clarifies the procedure for reevaluation of fitness to proceed after a finding of unfitness and attempts at restoration. <u>SB 2916, SD1, HD1</u> (<u>HSCR1146-16)</u> <u>Status</u>	RELATING TO PUBLIC SAFETY. Includes misdemeanor offenses under chapter 134, Hawaii Revised Statutes, relating to firearms, ammunition, and dangerous weapons, to the offenses that disqualify retaken and reimprisoned parolees from provisions regarding reincarceration and credit for time served. (SB2916 HD1)	PBS, JUD
<u>SB 2107</u> (HSCR1201-16) <u>Status</u>	RELATING TO PEN REGISTERS. Amends the definition of "pen register" to include cell phones and other communications devices among those that the numbers transmitted to and from may be recorded.	CPC, JUD
