Allows an employer to seek a temporary restraining order and injunction against further harassment of an employee or invitee who may be harassed in connection with a worksite.

RELATING TO THE OFFICE OF COMMUNITY SERVICES. LAB, FIN Appropriates general revenue for one full-time equivalent position as grant administrative support personnel in the office of community services for fiscal year 2016-2017.
