Restores the permanently exempt second deputy director position for the Department of Human Services. Establishes a secretary, community/project development director, and policy director positions. Exempts certain identified DHS positions from civil service status for three years. Appropriates funds for the newly established positions. (HB2348 HD1)	HUS, LAB, FIN
<u>HB 1807, HD1</u> (HSCR162-16) <u>Status</u>	RELATING TO MILITARY SERVICE. Authorizes reserve and national guard members to receive paid military leave while on inactive-duty training. (HB1807 HD1)	VMI, LAB, FIN
<u>HB 2486, HD1</u> (<u>HSCR191-16)</u> <u>Status</u>	RELATING TO ECONOMIC DEVELOPMENT. Establishes a Kapolei Jobs Initiative Program that offers tax incentives to increase the number of businesses willing to establish or relocate themselves in the Kapolei region. (HB2486 HD1)	EDB, LAB, FIN
<u>HB 2489</u> (<u>HSCR161-16)</u> <u>Status</u>	RELATING TO THE DEPARTMENT OF DEFENSE. Appropriates funds for the establishment of a veterans services counselor IV position within the Office of Veterans' Services to assist all veterans, with a primary focus on female veterans.	VMI, LAB, FIN
<u>HB 2693, HD1</u> (HSCR179-16) <u>Status</u>	RELATING TO THE STATE HISTORIC PRESERVATION DIVISION. Establishes two positions in the State Historic Preservation Division in the Department of Land and Natural Resources. (HB2693 HD1)	WAL, LAB, FIN

Implements the recommendation of the Hawaii agriculture workforce advisory board to create an agriculture workforce development pipeline initiative to conduct training on all islands for teachers and school administrators in agricultural self-sufficiency. HB 2226 Status	RELATING TO THE OFFICE OF LANGUAGE ACCESS. Appropriates funds for three full-time equivalent permanent positions within the Office of Language Access.	HUS, LAB, FIN
HB 2227 Status	RELATING TO LANGUAGE ACCESS. Appropriates funds to continue the operations of the Statewide Language Access Resource Center and Multilingual Website Pilot Project within the Office of Language Access.	HLT, LAB, FIN
<u>HB 2009</u> <u>Status</u>	RELATING TO HOISTING MACHINE OPERATORS. Repeals the Hoisting Machine Operators' Certification Revolving Fund and the position of the executive director. Allows the Hoisting Machine Operators Advisory Board to establish fees for the issuance of permits or certificates by administrative rule.	LAB, FIN

HB 2351 Status	RELATING TO SERVICES PERFORMED BY CIVIL SERVICE EMPLOYEES. <u>SB 2289, SD1</u> (<u>SSCR2017)</u> <u>Status</u>	RELATING TO LABOR. Requires employers to keep a record of the former physical addresses and current physical address of the employer and the North American Industry Classification System code applicable to the employer. Deletes anachronistic provision pertaining to insurance plan information. Effective January 7, 2059. (SD1)	LAB, FIN
