

As manager for government relations, was responsible for corporate government relations at the federal, state and county levels. Coordinated the development of legislation, wrote and provided testimony at the state legislature and county councils. Identified, prioritized and tracked legislative bills. Administered the company's political contribution fund, campaign spending and ethics commission filings.

- Designed and implemented the company's first comprehensive government relations strategy, which created a heightened awareness of government relations as an integral part of corporate decision-making and focused on developing senior management's network with state and county officials.

 - * Act 226, which enables developers to finance infrastructure via county bond initiatives.

As director of human resources, was responsible for salary and compensation, employment, training, benefits, safety, security, housing, and employee and community relations for the plantation's 355 employees. Supervised five personnel specialists.

 Re-established the Plantation's Labor Management Committee to address concerns regarding safety, health benefits, housing, and working conditions, which improved relationships with the ILWU. Grievances were reduced from more than twenty to zero in a two-year period.


