Anesthesia services was provided at this urban multi-specialty surgical practice, including: Neurology, OB/GYN, Orthopedics, ENT, Opthalmology, General, Vascular, Thoracic, Trauma, Oral and Maxillofacial, Plastic and Reconstructive, Urology, Podiatry, Radiology, Gastroenterology and occasionally Cardiac. General, regional, and MAC anesthesia services were provided. I provided epidural and spinal anesthesia and analgesia for obstetrical patients. This practice required 24-hour call. I participated in a monthly morbidity and mortality conference and was a resource person for OR and anesthesia personnel. This practice had a very busy phase 2 trauma practice covering a 4-state area. There were approximately 11,000 anesthetics given a year. I provided a preoperative assessment and counseling in the PAT (Pre-operative Assessment and Testing) center on a rotating basis.

# MOUNT CARMEL REGIONAL MEDICAL CENTER, PITTSBURG, KANSAS Staff Nurse Anesthetist, Adjunct Professor University of Kansas Anesthesia Education August 1993 to September 2001

A rural hospital setting providing general (General, regional, and MAC) to General Vascular, Thoracic, OB/GYN, Orthopedic, Urology, ENT, Podiatry, Oral and Maxillofacial, Ophthalmology, Gastroenterology, and occasionally trauma patients. There were approximately 4500 surgical cases a year performed. Anesthesia and analgesia was provided to OB patients. I was a 1st responder to in-house codes and other emergencies requiring anesthesia services. Beeper call (24 hour) every 4th day and 4th weekend was required. Some administrative duties such as staff scheduling, equipment and anesthesia product evaluations, and personnel review were required. In addition, I was an adjunct professor with the University of Kansas Nurse Anesthesia Education Department. This required both clinical and didactic instruction to students in this program. I was the thesis chairperson for students and helped develop and implement each student's research and thesis. I was very active in the selection, instruction, evaluation, and discipline of each student in the program.

# OWATONNA ANESTHESIA SERVICES, P.C.,, OWATONNA, MINNESOTA Staff Nurse Anesthetist

August 1991 to August 1993

A rural hospital setting providing anesthesia to approximately 3500 patients a year. Surgical services offered at this facility were OB/GYN, Orthopedic, Urology, ENT, Opthalmology, Gastroenterology, and occasionally trauma. This was a (fee per service) independent practice where we did our own billing for services rendered. General, regional, MAC anesthesia, and OB analgesia was provided to the patients on a 24-hour beeper call, every 4th day and every 4th weekend. I was the 1st responder to codes and emergency services at the hospital. Some pain management work was performed; trigger point and epidural steroid injections, as requested by attending physicians.
