This practice included consultancy work for, and co-counsel arrangements with, other attorneys and law firms.

M/V Oceanus*, *et al.*, in the FSM Supreme Court, a class action arising from environmental damages to a key coral reef on Satawal Island that was favorably settled, and the settlement funds applied to a community-based trust for environmental remediation, health, and education.

Co-counsel representing the preservationist plaintiff organization at trial and on appeal in Sandy Beach Defense Fund v. City & County of Honolulu, 70 Hawaii 480, 777 P.2d 244 (1989), a suit to enforce the public's right to vote in a referendum on development in environmentally sensitive areas, which was ultimately successfully settled to protect the worldrenowned Sandy Beach area of Oahu from adjacent development of luxury housing. Co-counsel and plaintiff at trial and appellate levels in *Burdick v*. Takushi, 524 U.S. 428 (1992), an unsuccessful attempt to establish a right guaranteed under the First Amendment for write-in voting, rejected by the U.S. Supreme Court on a 6-3 vote, despite prior favorable rulings in the California Supreme Court and the U.S. Court of Appeals for the Fourth Circuit. Co-counsel for local community association in extended bench trial and on appeal in successful litigation for accretion of their beachfront property, In re Application of Banning, 73 Hawaii 297, 834 P.2d 724 (1992).
