SB2585, SD1	RELATING TO THE STATEWIDE TRAFFIC CODE. Clarifies when pedestrians may enter a crosswalk equipped with a countdown timer. (SD1)	TRN
SB2647, SD1	RELATING TO NATURAL RESOURCES.  Prohibits the sale, offering to sell, purchase, trade, or barter of any part or product from various animal and marine species.  Provides exceptions to this prohibition, including for traditional cultural practices protected under the state constitution. Specifies that insurers, but not health care providers, are liable for civil damages caused by undue delays for preauthorization.
