SB2107	RELATING TO PEN REGISTERS. Amends the definition of "pen register" to include cell phones and other communications devices among those that the numbers transmitted to and from may be recorded.	CPC, JUD
SB2585, SD1	RELATING TO THE STATEWIDE TRAFFIC CODE. Clarifies when pedestrians may enter a crosswalk equipped with a countdown timer. (SD1)	TRN
SB2647, SD1	RELATING TO NATURAL RESOURCES. Prohibits the sale, offering to sell, purchase, trade, or barter of any part or product from various animal and marine species. Provides exceptions to this prohibition, including for traditional cultural practices protected under the state constitution. Imposes penalties for violations of the prohibition on trafficking animal parts and products. Takes effect 7/1/2050. (SD1)	WAL, JUD
