(1) Why do you wish to be a member of the Advisory Committee on Pesticides?

Using my extensive background and experience with Hawaii pesticide issues, I want to be part of a team to advise and assist the Pesticide Branch of the Department of Agriculture in developing and/or revising laws and rules to ensure that the use of pesticides will not harm Hawaii's fragile environment and watershed, and that they are safe for human and wildlife health.

(2) How do you perceive the role and responsibilities of a member of the Advisory Committee on *Pesticides*?

My role and responsibilities as a member of the Advisory Committee on Pesticides, representing the Hawaii Farm Bureau, will be to advise the Hawaii Department of Agriculture Pesticide Branch on new or revised pesticide laws and regulations that will assure pesticide safety and the judicious use of pesticides to effectively control invasive and harmful pests in the State of Hawaii.

(3) Given your understanding of the role and responsibilities of a member of the Advisory Committee on Pesticides, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Advisory Committee on Pesticides.

I am qualified to be a member of the Advisory Committee on Pesticides because of my educational background which includes a B.S., a M.S, and a Ph.D. in Entomology, with emphasis on integrating invasive pest management using both pesticides and nonchemical control strategies. I am also very familiar with the Hawaii Pesticide Law, in part through my training and qualifications as a Category 10 licensee under the stringent State-certification program. Additionally, I have worked with the Department and the community to help control invasive pests. I have researched and generated numerous efficacy and phytotoxicity data to support national and local registrations for the State of Hawaii. Furthermore, I have published over 70 refereed/peer-reviewed research papers in national and international journals on pesticides and nonchemical controls of invasive species. (4) What do you hope to accomplish during your term of service?

I hope to assist the Department in promulgating new and/or revised pesticide regulations that enable the use of safer and more effective new products and methods to help Hawaii battle against the continuous influx of new invasive species that significantly impact agriculture and our fragile endemic flora and fauna. I will work to assure that any current or new pesticides do not have a negative impact on non-target organisms and our environment.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Advisory Committee on Pesticides?

Innovative: As a researcher and extension specialist at the University of Hawaii for over 33 years, I have innovated new pesticide application techniques that target pest species and avoid effects on other organisms and the environment. For example, instead of spraying large amounts of insecticides throughout thrip and midge insect-infested orchid and anthurium plants; through our research, we discovered that strategically placing small amounts of granular product below the plant proved effective because it targeted the early stages of these destructive pests. As a member of the Advisory Committee on Pesticides, I will share my expertise and assist the committee through innovative ideas such as the use of application techniques and timing to minimize the effects of pesticides on non-target organisms.

Knowledge of

<u>Pesticides</u>: My education and career background has provided me with broad knowledge of current and historically used organic and non-organic pesticide chemistries, along with those now in development. As a member of the Advisory Committee, I will be able to advise the Pesticide Branch in registering the safest and most effective pesticides for use in Hawaii.

<u>Extensive</u>

<u>Network</u>: I have collaborated and cooperated with numerous farmers, county, state, and federal environmental agencies, and the pesticide industry, both within and out of state, on pesticide efficacy, phytotoxicity and registration issues for the State of Hawaii. I intend to share my extensive networks with the Pesticide Branch to help obtain necessary information on these complex issues and to assure that decision-making is made using the most current scientific data and experience. I have been deeply involved in the rigorous State of Hawaii pesticide registration process so I am very aware and knowledgeable about this complicated area of regulation. This experience will allow me to advise the Pesticide Branch on registering safer new alternative to assure no negative effects on humans, water, wildlife and the environment.

Relationship to Arnold

My name is Barry M. Brennan. I am an emeritus specialist with the University of Hawaii's College of Tropical Agriculture and Human Resources (CTAHR). I received my MS (1969) and PhD (1975) degrees in entomology from UH. For nearly 28 years I served as the Cooperative Extension Service's Pesticide Coordinator. In that capacity I worked closely with the Department of Agriculture on pesticide safety training, regulatory impact and needs assessment, and applicator certification. I served three terms on the Advisory Committee on Pesticides whose purpose is to advise and assist the Department of Agriculture develop or revise pesticide laws, regulations and policies.

I have known Dr. Hara since he was a graduate student in the Department of Entomology. As the Associate Dean and Director for Cooperative Extension Service I appointed him to serve as CTAHR's Integrated Pest Management Coordinator. In that capacity Dr. Hara focused on minimizing the use of pesticides to manage important pests of Hawaii's unique agricultural and floricultural crops. Evidence of his successful contributions to pest management is supported by numerous awards and recognition provided by his many clientele, their organizations, and by various professional associations. He is a member of Sigma Xi and Gamma Sigma Delta, both research honoraries.

Dr. Hara has published over 100 refereed articles, written 50 extension publications and other articles, and made numerous professional presentations. Many of his publications were jointly authored by other professionals, many of whom work for state and federal agencies. Suffice it to say that Arnold works well with others. His research is particularly important to halting the spread of pests both within the state and between Hawaii, the mainland, and foreign countries.

Dr. Hara has been innovative in developing techniques to manage a wide diversity of pests, from the coqui frog, to the little fire ant, to more common pests such as thrips, gall wasps, leaf miners, aphids, mealybugs, scales, and various plant pathogens. Arnold has worked on a number of pest management practices including the use of heat, hot water dips, irradiation, pesticides and biocontrol agents. His work with pesticides often focused on how to improve their efficacy while reducing their use, thus protecting both the applicator and the environment.

Dr. Hara's understanding of the role pesticides play in developing effective integrated pest management programs for Hawaii's agricultural and floricultural industries is well documented in his CV. I believe his experience and understanding of how, when and where pesticides are used in Hawaii give him the background needed to provide excellent advice to the Advisory Committee on Pesticides.
