(1) **LEILYN KOEV, GM 505**: Why do you wish to be a member of the Board of Directors of the Agribusiness Development Corporation?

My family has had a long history of farming in Hawaii, and I would like to continue what my Grandfather has left our family and to see it flourish and continue as farming was his passion. My grandfather was a fisherman and a farmer and my father a farmer as well. I hope to learn from the other board members diverse experience, take it back to my farm and implement techniques to continue expanding farming. I would like to build awareness of various farming operations and I believe this Board can teach me a lot in this aspect.

(2) How do you perceive the role and responsibilities of a member of the Board of Directors of the Agribusiness Development Corporation?

I believe the Board's position is to increase farming and agricultural activities based on the recent study which revealed such decline. It is a challenge in that the Board is trying to sustain potential farmers while ensuring that these farmers will provide an asset to the land they are receiving at a great value. It should be a win-win situation however I believe it is very difficult to find people of this generation who wish to farm and have the knowledge to pursue this endeavor. The Board must increase awareness and training for the younger generation of farmers to succeed. Farming has many new rules and guidelines (i.e. Food safety) which makes it very difficult for each farmer to change and/or to stay abreast of the many changes. With the help of ADC, I believe that the State could attract more interest in young farmers with the hopes of continuing and keeping the soils rich for agriculture and keeping local produce.

(3) Given your understanding of the role and responsibilities of a member of the Board of Directors of the Agribusiness Development Corporation, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Board of Directors of the Agribusiness Development Corporation.

This is a difficult question to answer as I am not your typical, "old-school" farmer with a lot of farming experience. I have sat through a few meetings and realized how little I know about land use and my scope of knowledge in farming is limited to hydroponic greenhouse tomatoes. With that being said, my experience with growing up and working on our family farm, I have specific skills which could be an asset for the projects that lay ahead. I have learned through first-hand experience what it takes for a small farm with limited amount of staff and income to go from a "family run business" to a farm corporation who has to adhere to new rules and regulations to keep up with the other farm grown products from the Continental US and globally. I was part of our company going from no food safety program to a certified food safety farm and packing house. To someone who is unfamiliar with farming, this may seem like an easy task, however when you go through and see what these small farms have to do to become food safety certified, the small farmer becomes discouraged and not willing to comply therefore we will have less local produce. Unfortunately these farms will be phased out as food safety is not an option, it is required, and I feel that if our farm was able to comply, so can they. We will lose many local products so long as these "old-time farmers" are pushed to the many regulations and we will have less people to farm thus less produce from Hawaii. I believe I could help with my firsthand knowledge that I gained from my farm.

(4) What do you hope to accomplish during your term of service?

I hope to be a part of the Board that helps to facilitate more local farmers to increase Agriculture for this State. It is my understanding that the ADC has many acres of good farm land including a potential packing house for those that farm. Having a centralized packing house where ideas are exchanged from the individual farmers will assist in producing food safe and quality products. This goes to the farming tenants as well. I would like to assist the Board in filling these lots and would be proud to be a part of sustaining agriculture in this State.

- (5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Board of Directors of the Agribusiness Development Corporation?
 - 1. I am very calm in nature and I do not get excited easily. This will assist in discussing controversial issues that may arise in the future board meetings.

 - 3. I have good interpersonal skills and able to get along with many different types of people. I believe this is important when you sit on a board with many talents and experiences.
