I want Hawai'i, in all her glory to be here for generations to come.

In consideration of GOVERNOR'S MESSAGE 511 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE NATURAL AREA RESERVES SYSTEM COMMISSION, GUBERNATORIAL NOMINEE, ANGELA KAWELO, FOR A TERM TO EXPIRE 06-30-2020

The Department of Land and Natural Resources (Department) strongly supports Governor's Message 511, nominating Angela Kawelo to the Natural Area Reserves System Commission for a term to expire June 30, 2020.

Pursuant to Section 195-7, Hawaii Revised Statutes (HRS), the Natural Area Reserves System Commission shall: (1) Establish criteria to be used in determining whether an area is suitable for inclusion with the reserves system; (2) Conduct studies of areas for possible inclusion within the reserves system; (3) Recommend to the Governor and the Department areas suitable for inclusion within the reserves system; (4) Establish policies and criteria regarding the management, protection, and permitted uses of areas which are part of the reserves system; (5) Advise the Governor and the Department on any matter relating to the preservation of Hawaii's unique natural resources; (6) Develop ways and means of extending and strengthening presently established preserves, sanctuaries, and refuges within the State; (7) Advise the Department and other public agencies managing state-owned land or natural resources regarding areas under their respective jurisdictions which are or may be appropriate for designation as natural area reserves; and (8) In carrying out the above duties, consult the most comprehensive up-to-date compilation of scientific data on the communities of natural flora and fauna of Hawaii. Ms. Angela "Hi'ilei" Kawelo has extensive background in native Hawaiian traditional and customary practices. She is the Executive Director of Paepae o He'eia, a non-profit dedicated to caring for He'eia fishpond, and has been with the organization for over fifteen years. She graduated from Punahou School and received a Bachelor of Arts in Zoology and a Marine Options Program Certificate from the University of Hawai'i at Mānoa. In addition to leading Paepae o He'eia, she shares her knowledge as a lecturer of Hawaiian Studies 353 – Mālama Lokoi'a at the University of Hawai'i at Mānoa. Ms. Kawelo's professional and educational background makes her a valued addition to the Natural Area Reserves System Commission.
