(1) Why do you want to be a member of the Board?

(2) What do you perceive are the roles and responsibilities of a member of the Board?

I was a Foreman for most of the projects and because of that I was able to work closely with the all of the other construction trades and have a very good working knowledge of the whole building industry. My experience in the electrical field went from an apprentice to Foreman to estimator to Union officer.

To provide the community and electrical industry in Hawaii a stable environment with current rules and regulations and to provide qualified electricians.
