## GM 544 – Steve Tsunemoto

(1) Why do you want to be a member of the Board?

Having been employed in the elevator trade for 29 years, I understand the importance of ensuring the quality of individuals employed in the elevator trade, specifically pertaining to the safety of the riding public. I feel I have the depth of experience to evaluate candidates applying for a elevator mechanic license here in Hawaii, as well as monitoring the actions of elevator mechanic license holders.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

The role and responsibly of the board is to ensure that the qualifications of the applicants are consistent with the requirements stated in HRS Chapter 448H and HAR Chapter 81.

(3) In what ways do you feel that you can help protect the consumer?

By ensuring that the experience and qualifications of the applicant are consistent with the requirements, I feel that we can at least be assured that a minimum knowledge of what is required to install, service and repair elevators and escalators in the State of Hawaii.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

As previously stated, I've been employed as an elevator constructor for the past 29 years, 25 of which as a journeyman, employed in all aspects of the trade, from construction, repair and service. In addition, I hold a Qualified Elevator Inspector certification and am currently an instructor in the National Elevator Industry Apprenticeship Program, with certification to train OHSA, First Aid and AED, Scaffolding, Fork Lift and Aerial Lift.

I've previously served two terms on the licensing board, including a term as chairman.

(5) What do you hope to accomplish during your term of service?

Personally, I would like to see some form of continuing education requirement be including in renewal of the license so that the license holder would be updated with changes in the code, especially pertaining to changes in the periodic testing of the various conveyances which elevator constructors are tasked to maintain.

In addition, I'd like to correct the variance in registration requirements for individuals registering in the State of Hawaii versus applicants requesting licensing from other parts of the country.

- (6) Name three qualities that best describe you and how these qualities will benefit the Board.
  - 1. I feel a responsibility to be involved in all aspects of the elevator trade, from training new apprentices to keeping abreast of changes in the code.
  - 2. I am not adverse to the work involved as a member of the licensing board.
  - 3. I am well versed in all aspects of the elevator trade.

I hope that my qualifications would complement the knowledge and experience of the board as a whole.

(7) Name a previous experience you've had that will be beneficial as a Board member.

Again, I've been a member of the Elevator Mechanic Licensing Board previously, as well as a member of the committee involved in the adoption of the Safety Code for Elevators and Escalators, 2010 edition, here in the State of Hawaii.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

There might be a perception that a conflict of interest exists due to my membership in the Union of Elevator Constructor Local 126, but I am well aware that the licensing board exists to ensure the safety of the public by reviewing the qualifications of applicants with confirmation by administering a test of basic knowledge. I feel that my training and continued emphasis on safety by the International Union of Elevator Constructors has more than prepared me for inclusion as a member of the licensing board.
