I hope this letter finds you well and not too exhausted by the demands of the Legislative session!

I have been on the Board of Acupuncture since my appointment by Gov. Abercrombie in 2011 and I am excited to have Dr. Joni Kroll apply for the recently vacant acupuncturist opening. This is a critical and exciting time for our medicine. Its integration in hospitals like Cleveland Clinic, Massachusetts General, MD Anderson and, of course, our own Queen's Medical Center, make it truly important that we have practitioners who want to advance the science and professional standards of Oriental Medicine and Acupuncture.

Dr. Kroll has been licensed to practice acupuncture by the State of Hawaii since 1989, she has effectively treated thousands of patients. GM 549 - Joni Kroll, Board of Acupuncture Nomination

- (1) Why do you want to be a member of the Board? It would be an honor to serve in a manner that allows me to use my nearly 3 decades of clinical experience and active involvement in the acupuncture profession in Hawaii in way that protects Hawaii citizens and helps navigate the integration of our ancient medicine into the Western health care system.
- (2) What do you perceive are the roles and responsibilities of a member of the Board?

Public safety and protection is the primary responsibility followed by keeping the State of Hawaii's laws and Rules and Regs instep with evolving professional standards.

(3) In what ways do you feel that you can help protect the consumer?

Review licensure applicants to assure they meet entry level standards for our profession. Use my 27 years in clinical practice to review and provide input on RICO complaints.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I completed my acupuncture training in Hawaii in the mid 1980's and have been blessed with a successful practice in Kailua for nearly 30 years. In addition to serving as the President of the Hawaii Acupuncture Association for several years, I also formed a nonprofit independent provider association that helped LAc's and insurance companies learn to work with each other in ways that benefited the consumer (developing standards for participation that included malpractice insurance, commercial office space, site inspections, etc.) I've also been legislative liaison which has given me insight and experience into the laws that govern health care practitioners. I have also taught courses on safety and ethics at the Institute of Clinical Acupuncture and Oriental Medicine. I've also learned to work well within the cultural diversity of our profession.

(5) What do you hope to accomplish during your term of service?

Be an active part of the ongoing Rules and Regulations revision process which will bring our State up to date with current national professional standards.

(6) Name three qualities that best describe you and how these qualities will benefit the Board.

Experienced - I know the community of acupuncturists in Hawaii. I also know the issues facing our state and I keep up with national issues that may become local issues.

Efficient - I've been on enough boards to know that making good use of the limited time we have is important. I know how to listen to others and speak in a manner that moves the often slow process of democracy forward! Discerning - I feel I am good at reading situations and people to understand their feelings and thoughts about issues as well as recognize when ulterior motives may be at play.

(7) Name a previous experience you've had that will be beneficial as a Board member.

I have served as a member of RICO's advisory panel for acupuncture and have reviewed some very difficult complaints where I had to carefully weigh the patient's complaint with the practitioner's actions and determine if the actions fell outside our scope of practice. In one particular instance, my determination was that the practitioner had indeed acted in an unprofessional manner and outside the scope, resulting in harm to the patient which ultimately led to sanctions and loss of licensure to the practitioner.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

The only conflict of interest I can foresee would be in reviewing an applicant for licensure that had done part of their clinical internship with me. In such a case, I would recuse myself from voting.
