(1) Why do you want to be a member of the Board?

I've been a Board member for nearly six years and would like to continue in the role as the county of Maui representative on the Board of Certification of Operating Personnel in Wastewater Treatment Plants (BOC).

During these past years while on the BOC, the members have continued to strive in improving the professional image of the Wastewater Treatment Operating Personnel through regulating and enforcing the certification requirements of Hawaii Administrative Rules 11-61 and the overall knowledge of all operating personnel.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

The main role and responsibility of the BOC is to ensure that all operating personnel adhere to the requirements of the Hawaii Administrative Rule 11-61. These rules provide the minimum requirements for all level of operating personnel in wastewater treatment in the State of Hawaii.

(3) In what ways do you feel that you can help protect the consumer?

The members of the BOC ensure that all operating personnel adhere to Hawaii Administrative Rules 11-61 which provide the minimum requirements of all operating personnel. By doing so, the BOC members protect the waters and environment of the State of Hawaii.

During the past years as a BOC member and as a Certified Operator, I've experienced the struggle that a person goes through as they evolve in their careers. Most of these are internal and can only be overcome as more people see the role of the Operator as a true professional and not just as a knowledgeable laborer.

(8) Can you foresee and possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

The only conflict that I've encountered so far is of time. The amount of time required to ensure that what is discussed during executive meetings and the decisions from those meetings are towards the goals that I have set for myself. The only way to avoid or minimize these conflicts is to prioritize my schedule and allot sufficient time to ensure a high quality result.
