SUBJECT: GM 567 - State Council on Developmental Disabilities Gubernatorial Nominee Edna Kaahaaina

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 567** to confirm the nomination of Edna Kaahaaina for a term to expire June 30, 2019.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the stakeholders are represented and engaged in the development and implementation of a comprehensive system of services and supports for individuals with DD.

The law specifically requires that not less than 60 percent of the membership of the Council be comprised of individuals with DD, parents, immediate relatives or guardians. Additionally, each Council shall include representatives of relevant State entities, including State entities that administer funds provided under Federal laws related to individuals with disabilities, including the Rehabilitation Act of 1973 (29 U.S.C. 701 et seq.), Individuals with Disabilities Education Act (20 U.S.C. 1400 et seq.), Older Americans Act of 1965 (42 U.S.C. 3001 et seq.), and Titles V and XIX of the Social Security Act (42 U.S.C. 701 et seq. and 1396 et seq.); Centers for Excellence in DD Education, Research, and Service; State Protection and Advocacy system; and representatives, at all times, of local and non-governmental agencies, and private nonprofit groups concerned with services for individuals with DD in the State.

The Governor's nominee meets all the Federal requirements for Council membership. Ms. Kaahaaina's appointment to the Council would fulfill the Federal requirement for parent representatives on the Council. She is a parent of a son with special needs in middle school.

During the past year, she has been involved as a member of the Council's Health and Early Childhood Committee which addresses the State Plan Goal, "Children and youth with special health care needs and their families have access to familycentered community-based integrated interventions and supports providing opportunities to ensure quality of life." Her appointment would assist the Council to address its State Plan Education Goal 1, "Students with intellectual and developmental disabilities have quality education outcomes, including vocational and life skills training," and carry out activities relating to increased access to information on supports needed to prepare students for the transition from middle school to high school, and to adult life.

We appreciate the opportunity to express our strong support for GM 567 to confirm the appointment of Edna Kaahaaina to the State Council on Developmental Disabilities.
