4	Dr. Koyanagi fills the SCMH in the capacity of a principal state agency with respect to social
5	services - MedQUEST Division. Dr. Koyanagi also fulfills the dual role on the SCMH on the
6	Hawaii Advisory Commission on drug abuse and controlled substances because he is
7	knowledgeable about the community and the relationship between mental health, mental illness
