To Chairperson Baker, Vice Chair Kidani and the Members of the Committee:

My name is Roger Bruhn and I have served as an officer and board member of Islands Hospice, Inc., since our inception in 2008. In the past 8 years I have worked with the SHPDA staff in a host of complex matters. As you know, Susan Romala Radcliffe serves as the Administrator of the agency.

Her steady hand that oversees the Certificate of Need (CON) process for the State of Hawaii is assuring to providers. I have witnessed her managing the tension of determining where need exists and where it does not. When we received our first CON in 2008, the state was poorly underserved in the area of hospice care. SHPDA and staff dutifully studied the statistics that we supplied and the sub-area panels ultimately agreed with our application and we received a positive Decision on the Merits.

It takes sure-handedness to arrive at healthcare-related determinations, because the Administrator is constantly faced with the fact that the outcome will be unpopular with some. Ms. Radcliffe seems unfazed by this both during public hearings and in her writings.

One of the core-competencies that I applaud the entire SHPDA staff for is that they always refer providers and applicants back to the Health Services and Facilities Plan and to applicable state statutes. By doing so they remain consistent and the entire agency avoids decisions that are arbitrary and capricious. Instead good and bad applications alike are given a clearly articulated plumb-line. The outcome is consistency and the decisions follow the intended framework for the agency.

When I reflect on the our earliest days, when we had just 1 location and 0 patients, and I compare that to Islands Hospice today, with 4 locations that serve both Oahu and Maui, hundreds of dedicated and skilled staff members and thousands of patients that have received our care; I am convinced that the SHPDA CON process is a great contributor to our success. It forced us in our earliest genesis to focus on data that supported our case that there was existing need for end-of-life hospice care. And the CON process further caused us to reflect on our quality, financial stability, whether or not the resources that we required were available and, lastly, to compare how our plan relates to the Health Services and Facilities Plan and to the existing healthcare continuum. Said plainly - Ms. Radcliffe and the SHPDA staff cause us (and all providers) to sharpen our focus.

In our case, the true benefactors are the thousands of patients that have received, and continue to receive, care.

I strongly support Ms. Radcliffe's nomination as Administrator of SHPDA. And I am glad to answer any further questions that any of the members might have.

Thank you for this opportunity to provide testimony and to respond to the questions below.

I have had the pleasure of serving as the Administrator of the State Health Planning and Development Agency (SHPDA) since April of 2011.

Since 1975, SHPDA has been the State's principal agency charged with the duty of promoting accessibility for all the people of the State of Hawai'i to quality health care services at reasonable cost. To accomplish our objectives we:

- Conduct studies and investigations regarding the causes of health care costs
- Promote the sharing of facilities or services by health care providers to achieve economies of scale and restrict unusual costly services
- Conduct coordinated health planning activities and determine health needs of the State.
- Administer the State's Certificate of Need (CON) program
- Serve as staff in the preparation, revision, and implementation of the State's Health Services and Facilities Plan

(1) Why do you want to be a member of the Board?

I want to continue the great legacy of community health planning that was left for the agency by my predecessors, started under Governor Ariyoshi's leadership previous SHPDA administrator were: Sylvia Levy, Henry Thompson, James Swenson, Kenam Kim, Kinau Boyd Kamalii, Marilyn Matsunaga, Dr. David Sakamoto and Ronald Terry.

For over forty years SHPDA has maintained close, deeply rooted ties with our communities. SHPDA actively listens to the needs of the six statewide health planning councils. The agency consistently provides educational forums for the members and the general public on health needs that are identified by the councils. (2) What do you perceive are the roles and responsibilities of a member of the Board?

As the Administrator for SHPDA I act as the Executive Secretary to the twenty member, governor appointed, Statewide Health Coordinating Council. My daily efforts are to direct the staff of specialized technical personnel in health systems planning, regulatory (CON) procedures and development functions. Since I began in 2011, SHDPA has revamped our website twice. Our site includes healthcare service utilization reports. In 2012, with the assistance of IDSD we began filming and uploading our education sessions onto YouTube. Educational topics include ACO and Bundled Payment, Advancing the National Strategy for Quality Improvement in Healthcare, Elder Abuse, Early Detection of Alzheimer's, Home and Community-Based Services, and Telehealth and Telemedicine in the Pacific Command. The SHDPA website offers a complete listing of every CON application since 2005.

(3) In what ways do you feel that you can help protect the consumer?

Supporting the consumer includes allowing them to participate in our shared responsibility of achieving optimal health. All of SHPDA's seven councils are led by consumers. We are all consumers of healthcare services. SHPDA's mission is to promote accessibility for all the people of the State to quality health services.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

As an administrator I must live up to the public's expectations for inclusion in planning processes. Planning activities are public investments made today to anticipate and meet future needs.

The privileges and opportunities that I have been afforded include 24 years of college courses. I am a practitioner of lifelong learning. I have received training as a conflict mediator, paralegal, audiometric technician, real estate agent, CPR and First Aid instructor, licensed nursing home administrator, life and health Insurance sales person, DOE substitute teacher, cancer navigator and memory care support navigator.

As the Administrator for SHPDA I use all of my training to evaluate the certificate of need applications.

(5) What do you hope to accomplish during your term of service?

The State Health Planning and Development Agency looks forward to continuing our efforts to serve Hawai'i's people. DOH's State Health Improvement Plan and the Governor's Office SIM grant initiates can serve a guiding documents in the next State Health Services and Facilities

Planning (SHSFP) process. The Statewide Health Coordinating Council will advise the agency on when to review the current plan and determine the next planning cycle.

(6) Name three qualities that best describe you and how these qualities will benefit the Board.

I am customer focused, I am community minded and honor all of my commitments. These qualities serve SHPDA well. With my support the staff will continue to provide excellent customer service. We will increase the number of community appointees that apply to serve on the six councils and I have never not followed through on a commitment that I have made.

(7) Name a previous experience you've had that will be beneficial as a Board member.

Back in the early 1980's the W. K. Kellogg Foundation and the Robert Wood Johnson Foundation offered Maui County community member's leadership training. I had no idea that with their training, thirty years later, I would be in a position to assist The Robert Wood Johnson Foundation with their mission to focus on the delivery of health care to the patient. Specifically, the Foundation concentration was on three aims: improving access to health care, improving health care services to enhance the quality of care, and developing methods to objectively analyze public health policy.
