The Environmental Council (EC) is pleased to submit testimony in support of the nomination of Scott Glenn as the Director of the Office of Environmental Quality Control (OEQC). Mr. Glenn is highly qualified for the position through a combination of his education, his work experience, and a history of volunteering as both a member and a previous chair of the EC.

The OEQC's primary function is to administer Hawaii's environmental review process under HRS 343. In this area, Mr. Glenn offers a depth of knowledge and experience that is essential for that office to perform its duties in a professional and competent manner. His private sector experience as a planner demonstrates his command of the technical aspects of the environmental review process. I strongly endorse and recommend <u>Scott Glenn</u> for Director of the Office of Environmental Quality Control (OEQC) for the reasons enumerated below.

I first met Scott while he was conducting research as a graduate student at the University of Hawaii's Department of Urban and Regional Planning. Scott was collecting information from regulators state-wide regarding the effectiveness, efficiency, redundancies, and value of Hawaii's environmental review system. At the time, I served as Maui County's Shoreline Planner where I regularly dealt with triggers for HRS 343. I was the lead planner for projects involving use of the shoreline area, conservation district, Lahaina National Historic Landmark District, and government initiated or funded projects in county parks and state harbors. I was responsible for processing Environmental Assessments (EA) and Environmental Impact statements (EIS) for these projects to ensure proper mitigation of potential adverse impacts, public transparency and input gathered, and that decision makers, such as the Maui Planning Commission, had sufficient information and data to make sound determinations.

In conducting his research, Mr. Glenn took the time and had the vision to meet with citizens, landowners, developers, consultants, and activists to gain greater insight into the current system's merits, pitfalls, and shortcomings. He also studied and extensively researched other state environmental review systems used by our mainland counterparts such as California and Washington, as well as the federal National Environmental Protection Act (NEPA).

Serving as a volunteer on the State Environmental Council, Mr. Glenn worked with passion and integrity to collaborate with stakeholders to develop proposed rule amendments to improve Hawaii's environmental review system. He eventually served as Chair of the State Environmental Council.

Mr. Glenn's diligence and thoroughness in analyzing data and procedures to better inform policy resulted in amendments to HRS 343 that reduce redundancy in the EA/EIS system. This single amendment saves considerable time and money when pursuing an EIS without sacrificing public transparency.

Mr. Glenn went on to work at TEC, Inc., a private consulting firm, as a fellow Environmental Analyst. Scott and I were actively engaged in a number of multi-million dollar harbor, energy, and military projects both here in Hawaii and throughout the Pacific. These projects required an in-depth and thorough understanding of state, territorial, federal and overseas environmental laws and systems of review. For example, Scott helped author, process, and respond to public comments for one of the largest EIS ever written for the U.S. military to relocate troops from Okinawa, Japan to Guam. He also helped a number of private clients, as well as NOAA, the Hawaii Department of Transportation, and Hawaii's Army National Guard in developing land use projects and conducting facility improvements.

I have no doubt that Scott will bring energy, enthusiasm and a quick wit to the Director's role at OEQC. But more importantly, <u>Scott understands and has experience in both the</u> <u>private and public sector</u>. With this knowledge, he will significantly improve the efficacy of our current process and procedure for environmental review. He will contribute to a more sound policy for project review, public transparency, and decision making that would better serve Hawaii's sustainable development, it's citizens, and the aina which we rely on. As such, I strongly encourage you to approve his nomination to lead the Office of Environmental Quality Control.

Testimony in support of GM 637 – the Governor's nomination of Scott Glenn to be the Director of the Office of Environmental Quality Control

Aloha Chair Wakai, Vice Chair Slom and Members of the Committee,

My name is Anthony Aalto, I am a journalist, documentary filmmaker and one of the elected leaders of the Sierra Club of Hawaii which is the largest environmental organization in the state. We have over 12,000 members and supporters, split amongst our four county groups. I am the Chair of the O'ahu Group, but I am testifying today as an individual.

I have know Scott Glenn for more than six years, ever since he and I first became involved with the Club.

The battle between developers and environmentalists is typically portrayed as a zero-sum game: a war in which the winner takes all, often after years of costly legal fights. In recent years the Sierra Club of Hawaii has tried to look for areas of compromise. Uniquely amongst environmental groups we have recognized the need to build tens of thousands of affordable homes to accommodate a growing population of kama'aina. It was for this reason that we chose to support the HART rail project. We see the rail project as providing an opportunity to build dense communities in the urban corridor which will allow us to keep the country country. It was not a popular decision, but we believe it was a responsible one. Scott was extremely influential in guiding the discussions and helping lead the Club to adopt this policy.

The approach to the HART issue was in turn a reflection of the Club's attitude that protecting the environment is not a luxury, nor a sacrifice, but an essential investment that will reap benefits for our economy as well as for the health and well-being of our citizens and future generations. Again, Scott was highly instrumental in helping shape this approach.

That philosophy led him to help found and lead the advocacy group Better Block Hawaii, whose goal is to create a better built environment and to improve the quality of life of ordinary working people.

In his professional career as a planner and a consultant helping clients like OHA, the state Harbor Division and the US Department of Defense to address the environmental assessments and impacts required to advance their projects, Scott has demonstrated the same determination to meld environmental concerns with economic needs in a way that benefits the entire community.

Scott brings a sharp intellect and an unimpeachable ethical standard to everything that he does. I cannot think of anyone who would be a better public servant in this position and I urge the committee to approve his nomination.
