Dear Senator Baker, Senator Kidani, and Members of the Committee:

SUBJECT: GM 685 - State Council on Developmental Disabilities Gubernatorial Nominee Sarah Ahina

The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 685** to confirm the nomination of Sarah Ahina for a term to expire June 30, 2020.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the stakeholders are represented and engaged in the development and implementation of a comprehensive system of services and supports for individuals with DD.

The law specifically requires that not less than 60 percent of the membership of the Council be comprised of individuals with DD, parents, immediate relatives or guardians. Additionally, each Council shall include representatives of relevant State entities, including State entities that administer funds provided under Federal laws related to individuals with disabilities, including the Rehabilitation Act of 1973 (29 U.S.C. 701 et seq.); Individuals with Disabilities Education Act (20 U.S.C. 1400 et seq.); Older Americans Act of 1965 (42 U.S.C. 3001 et seq.); and Titles V and XIX of the Social Security Act (42 U.S.C. 701 et seq. and 1396 et seq.); Centers for Excellence in DD Education, Research, and Service; State Protection and Advocacy system; and representatives, at all times, of local and non-governmental agencies, and private nonprofit groups concerned with services for individuals with DD in the State.

The Governor's nominee meets all the Federal requirements for Council membership. Mrs. Ahina is an individual with a developmental disability who resides in Waianae. She was first appointed in July 2009 to serve on the Council. She is a

graduate of the Council-sponsored Partners in Policymaking (PIP) Leadership Academy. The PIP Academy is an innovative program for individuals with DD and family members of individuals with DD. The program is designed to provide information, training, resources and skills, which promote productive partnerships between people who need and use services and those in position to make policy and law.

She is motivated to become a leader in self-advocacy and mentor other individuals to become their own advocates and to start their own business. She serves as an example of a person who had managed her own business, "Keoni Kanaloa Da Kine Crafts." Her business involved making pillows, blankets, pouches, and various hair and ear ornaments. Due to her visual limitations she is no longer actively involved in making her crafts. However, she continues to motivate others by telling her story, and how she had started and managed her own business.

Mrs. Ahina is one of the founding members of the Hawaii Self-Advocacy Council (SAAC). She was SAAC's past President and currently serves as its Historian. She is active in providing training to other self-advocates about emergency preparedness.

Her reappointment will assist the Council in its activities to promote selfdetermination and empowerment for individuals with DD to become self-advocates, and increase employment opportunities in the community.

The Council is pleased with Mrs. Ahina's nomination to continue serve on the Council and looks forward to her contributions to improve the quality of life for individuals with DD.

Thank you for the opportunity to express our strong support for **GM 685** to confirm Sarah Ahina to the State Council on Developmental Disabilities.

 I want to make a difference in the lives of individuals with developmental disabilities (DD) in the area of self-advocacy by working side to side with the DD Council.
