Laura KM Colbert SHCC

(1) Why do you want to be a member of the Board?

I am interested in continuing to serve as a community member of SHCC. As such, continue serving the community interest, sharing my experiences and knowledge of the healthcare industry.

- (2) What do you perceive are the roles and responsibilities of a member of the Board? Providing objective community insights in an advisory capacity to the SHPDA Executive Director, focusing on the Certificate of Need applications and the Health Services and Facilities Plan.
- (3) In what ways do you feel that you can help protect the consumer?

I bring my financial understanding of business and operational effectiveness in assessing the prospective viability of businesses to the review of CON applications to protect the consumer from businesses that are short-lived and those unable to meet the quality standards of both healthcare and viable financial viability.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

Having spent 12 years in the healthcare industry in several roles, as a financial analyst to strategic planning to operations manager, I believe I can bring insights to the SHCC.
