Chair Keith-Agaran and Members of the Committee:

The Attorney General supports the reappointment of Peter Hamasaki to the Commission to Promote Uniform Legislation of the Department of the Attorney General.

The Commission to Promote Uniform Legislation is advisory to the Attorney General and to the Legislature on matters pertaining to uniform legislation. Members of the Commission are Hawaii's representatives to the National Conference of Commissioners on Uniform State Laws, which is also known as the "Uniform Law Commission." The National Conference requires that each appointed commissioner be a lawyer licensed to practice law and that each commissioner personally attend and participate in its annual meeting.

Peter Hamasaki is a lawyer licensed to practice law and has regularly attended and participated in the annual meetings of the National Conference and the National Conference's committee meetings. The National Conference's committee appointments are selectively made by the President of the National Conference -- not all members of the National Conference have the privilege of serving on a committee. Since his initial appointment, he has served as a member of the National Conference's Drafting Committee on Registered Agents and Annual Filing Requirements Act, the Standby Committee on Model Registered Agents Act and Amendments to Entity Acts to Rationalize Annual Filings, the Drafting Committee to Revise the Uniform Law on Notarial Acts, and on the Standby Committee to Revise the Uniform Law on Testimony of the Department of the Attorney General Twenty-Eighth Legislature, 2016 Page 2 of 2

Notarial Acts. Since his last reappointment, Commissioner Hamasaki attended the National Conference's annual meetings held in Tennessee, Massachusetts, Washington, and Virginia.

In addition to attending the meetings of the National Conference, Commissioner Hamasaki has regularly attended and participated in the meetings and activities of the Commission to Promote Uniform Legislation. In the promotion of uniform legislation, the members of the Commission provide information on uniform laws to interested organizations, officials of the Executive Branch, and interested legislators, including presenting testimony during hearings on bills to enact new or revised uniform laws. Since his last reappointment, Commissioner Hamasaki prepared correspondence and testimony on bills to enact the Uniform Commercial Code Article 9 Amendments, the Uniform Commercial Code Article 4 Amendments, the Uniform Partition of Heirs Property Act, and the Uniform Fiduciary Access to Digital Assets Act.

In view of his demonstrated commitment to the promotion of uniform legislation and his continuing participation in the activities of the National Conference and of the Commission to Promote Uniform Legislation, the continued service of Peter Hamasaki as a member of the Commission and of the National Conference will be greatly beneficial to the State of Hawai'i and the National Conference. Consequently, the Attorney General respectfully requests that this Committee recommend the confirmation of the reappointment of Peter Hamasaki to the Commission to Promote Uniform Legislation.

Thank you very much for this opportunity to testify in **strong support** of Senate confirmation of **Peter Hamasaki** to another term on the State Commission to Promote Uniform Legislation.

I have had the pleasure of working with Peter as a fellow commissioner for the past twelve years and can attest that he is a conscientious, dedicated, and hard working commissioner. During his years as a commissioner, he has served on the Drafting Committee on the Revised Uniform Law on Notarial Acts, as well as the Model Registered Agents Act.

Beyond the development of proposed uniform laws at the national level, Peter has assisted our commission by being the consummate "team player". He has been involved locally by volunteering to testify at legislative hearings on any number of measures to enact proposed uniform laws. During this year's legislative session, he is serving as the Hawaii commission's lead testifier at legislative hearings on the Uniform Fiduciary Access to Digital Asset Act (UFADAA)—which he also did last year. Additionally, prior to the enactment of measurers, and at times even before their introduction, he has demonstrated a willingness to meet and work with interested parties, such as various sections of the Hawaii State Bar Association. I strongly support the nomination of PETER HAMASAKI to serve another term on Hawaii's Commission to Promote Uniform Legislation ("CPUL").

All of the commissioners on the CPUL serve as commissioners to the Uniform Law Commission ("ULC"), which is a body of attorneys from all States who spend countless hours, without pay, to develop proposed laws to be enacted in all States. ULC's goal is to provide uniformity in the laws among the States without sacrificing control to the federal government. The best known products of ULC include the Uniform Commercial Code, the Uniform Probate Code, the Uniform Transfers to Minors Act and the Uniform Partnership Act, all of which have been adopted in Hawaii; these and other uniform laws affect the lives of residents of Hawaii and other States every single day.

A ULC commissioner's duties are two-fold: First, the commissioner needs to participate in the drafting of uniform laws, including the careful review and consideration of their provisions on a line-by-line, and sometimes, word-by-word, basis. Secondly, the commissioner needs to work with the legislature of his or her State to get uniform laws enacted.

Peter Hamasaki has many obligations in his private law practice, but he has never hesitated to devote the time and energy necessary to fulfill the duties of a commissioner. Working with Peter on the CPUL, I have observed first hand his active participation in all phases of the long and detailed process of preparing a uniform act for enactment – (1) working on drafting committees at meetings during the year to discuss and draft new acts for presentation to all the ULC commissioners at the annual summer meetings, (2) attending the annual meetings (at times at his own expense) to consider and finalize the products of all drafting committees, and (3) preparing testimony and testifying in support of the uniform acts at the legislature. Peter also quickly responds to questions from legislative staff and any parties interested in the uniform acts that he has worked on to give them the information they need to understand the proposed legislation and its benefits.

I support the nomination of Peter Hamasaki for an additional term on the CPUL without reservation. Peter has been and will continue to be an outstanding commissioner on the CPUL and an outstanding representative of Hawaii to the ULC. I strongly urge you to recommend that the Senate confirm his nomination.
