(1) Why do you want to be a member of the Board?

After serving as a commissioner for almost 4 years on the Real Estate Commission, I feel like I have been educated with regard to the policies and procedures of this board. Having gained this knowledge I feel a sense of obligation to continue my work with Real Estate Commission for a second term. I bring a commonsense approach to these matters which have value and can be calming at times when we have some of our more intense meetings.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

First and foremost is consumer protection! I always weigh in on the degree of consumer harm when we are faced with disciplinary actions before making any decisions. Besides disciplinary action, we focus our attention on several areas of real estate, specifically condominiums, laws & rules and education. We are also tasked with providing real estate information to both the public and licensees. We preview and are responsible for approval of all appropriate real estate continuing education classes.

(3) In what ways do you feel that you can help protect the consumer?

I am a practitioner, with over 30 years of experience as a licensed agent. I bring a broad-based knowledge of consumer expectation and how to address their concerns. The most important way to protect the consumer is through education. If the consumer has a clear understanding of why things are documented the way they are, then it will be less likelihood of anyone getting harmed. It's often a matter of "putting out fires" before there is a problem.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I believe I am qualified to be on the commission because I have already had almost 4 years of experience. I have gotten past the protocol learning curve and now have a much stronger and beneficial understanding of the business at hand. I share a balanced approach to our meetings which helps stabilize the role and responsibilities of the Real Estate Commission's decisions. Another advantage I have is that I have served in several other capacities for the state which have provided me with a well rounded understanding of the state system. (5) What do you hope to accomplish during your term of service?

During my second term I will continue to bring a practical approach to the duties and responsibilities we have as commissioners, while maintaining a balance in my business and family life. I also hope to help mentor the new commissioners that come aboard in the future so that they will have a clearer understanding of our obligations as real estate commissioners. I am committed to this position and my attendance record is reflective of that. In almost 4 years of service, traveling inter- island two or more times a month for meetings, I only missed one meeting due to a family medical situation.

(6) Name three qualities that best describe you and how these qualities will benefit the Board.

Fairness, keeping an open mind, and treating others how I would like to be treated ( the Golden Rule). My thing has always been to give everyone a fair shake in life. I am well aware that there will always be a certain amount of subjectivity because as humans we often interpret the same situation differently. However I believe that if you practice decision making within the above mentioned parameters you will be on the right track.

(7) Name a previous experience you've had that will be beneficial as a Board member.

I was the president of our board in 2010 and for years I served on our Realtor's Association of Maui (RAM) grievance committee. I have almost completed my first four-year term as a state Real Estate Commissioner and have learned how to interact effectively with staff. In fact I have learned so much over these past years serving in this position, that I feel a sense of commitment to continue the work ahead , especially now that I have the gained so much valuable experience as a real estate commissioner.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

I could not predict with any degree of certainty, any upcoming conflicts of interest. However, I'm definitely conscious of the possibility and if such a instance should arise I would recluse myself from that particular situation. In fact if there was any suspicion of a possible conflict of interest I would consult with our deputy AG. Although I may wear different hats in all my day to day activities, I am certainly cognitive of which role I am fulfilling at any given time.
