Aloha Senator Baker,

It is with great enthusiasm I write to you in support of my professional colleague and co-worker, Mr. Tom Joslyn, CRNA, BSN, APRN, for reappointment to the Hawaii State Board of Nursing. I have known Tom since the mid 2000s and have worked with Tom in a number of capacities since January of 2009. We are both Certified Registered Nurse Anesthetists (CRNAs) and full time civilian employees of the Department of Defense at Tripler Army Medical Center (TAMC). - Why do you want to be a member of the Board?A. I wish to share my time and experience helping to protect the people of Hawaii, by my continued involvement with the BON.
- What do you perceive are the roles and responsibilities of a member of the Board?
 A. My primary role is to evaluate Nurses and their qualifications to practice in the state. The other important role is to evaluate new legislation and assist with rules to implement that legislation.

 A. To do the work I have done these last 3 years to again evaluate nurse's qualification for licensure and to determine if they are qualified to practice in the state. I also answer questions by the consumer concerning practice issues.
