In addition, I am now working with the State of Hawaii Department of Agriculture on creating an efficient and collaborative system for improving and retaining Hawaii's agricultural water resources.

It would be an honor for me to serve as a Director to the Agribusiness Development Corporation and to be a part of Hawaii's evolving agricultural industry.

(2) How do you perceive the role and responsibilities of a member of the Board of Directors of the Agribusiness Development Corporation?

The role in my opinion is to support the work of the Chair and the staff in ensuring that the agricultural lands under its management are strategically leased to increase the production of a diversified industry with an emphasis on food production. This includes involving smaller farmers, looking at alternative energy resources and creating efficient and affordable water resources. I also hope that with an increased infrastructure ADC can create partnerships that support agricultural production in terms of resource management and distribution facilities and networks.

(3) Given your understanding of the role and responsibilities of a member of the Board of Directors of the Agribusiness Development Corporation, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Board of Directors of the Agribusiness Development Corporation.

As the co-founder and President of Feed The Hunger Foundation, I have managed loan programs and created food networks both domestically here in Hawaii and in California, and internationally in 7 different countries where the focus of our programs has been in agricultural and food system loans. I believe I have an understanding of some of the issues regarding creating a strong agricultural industry that not only involves financial resources but needs creative partnerships up and down the food production chain to help farmers succeed. I have created partnerships between both small farmers, larger farms, non-profit foundations, technical support providers, marketers, and distribution networks to ensure the success of not only the farmer but of the community that needs more access to healthy local food.

I am also now currently working with the Department of Agriculture to help create more efficient and more plentiful resources for agricultural water. It's a very timely issue as we move further and further away from the big agricultural companies and attempt to invigorate a more diversified agricultural industry.

(4) What do you hope to accomplish during your term of service?

I hope to help increase the focus on food production and on ensuring that smaller farmers have access to resources for successful businesses. As I had mentioned before, this involves more than just access to affordable land. And in addition, I hope to help create efficient systems of water delivery, energy production for the farmers, and increase the ability to partner with private businesses.

(5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Board of Directors of the Agribusiness Development Corporation?

My experience in working with small farmers and in the agricultural industry in Hawaii and internationally is a quality that I believe is essential. The ability to communicate with and for smaller farmers is also another strong quality. And lastly I would name my ability to form partnerships and to work collaborative towards creative solutions would help benefit ADC.

(6) Name one previous experience that would make you stand out. How would this benefit the Board of Directors of the Agribusiness Development Corporation?

One example would be a meeting that I was able to convene last year between a group of approximately 15 different small farmers and the Agricultural Committee of the Senate. The purpose of this meeting was to give the farmers direct access to the Senators to talk about issues and challenges that they face as they try to create and maintain sustainable food production businesses. This was a challenge initially as the farmers are rarely willing to take the time of their farms to speak directly with lawmakers which many were not comfortable doing. First because they are so busy but secondly because many feel as though they will not be heard.

However because of our foundation's relationship with them, they believed that there could be benefits to being able to communicate directly with the people who could make changes in policy. It was very productive and I feel this is an essential piece to having organizations like ADC respond to and create programs that directly support our farmers.

(7) Can you foresee any possible conflicts of interests that could arise during your service on the Board of Directors of the Agribusiness Development Corporation? How would you overcome any possible conflicts of interest?

I do not foresee any areas of conflicts but if they should come up, I would recuse myself from the vote.
