RE: Responses to Questions on Nomination to the Hawaii State Board of Education

HEPC takes no position on the nominees. Rather, we respectfully suggest the kinds of responses, knowledge, and experiences that are particularly helpful for the Board of Education.

Specifically,

1) Why do you wish to be a member of the Board of Education?

It is all well and good to be a graduate of public schools, to love children, to be passionate, to want to do the best for the children of Hawaii. However, there are tens of thousands of our citizens who could say the same thing.

HEPC encourages the Committee to dig deeper. Some questions and knowledge that might be useful would be the following:

- What is your understanding of the mega trends in public education in the US and Hawaii?
- What is your personal definition of an educated adult?
- What are the most difficult challenges you see for public education?
- What kinds of data, information, and analysis of public education do you regularly consult?
- Can you provide two or three examples of public education excellence in Hawaii that you would like to see adopted by more schools?
- What is your view of the so-called school empowerment movement in Hawaii?

2) What do you perceive to be the role and responsibilities of a member of the Board of Education?

HEPC encourages the Committee to explore candidates' understanding of any higher level policy board.

- What is your definition of "micromanagement?"
- What is your view of how much time (weekly or monthly) a fully engaged Board member should dedicate to the task?
- What is your view of the ability of the public to provide meaningful and detailed testimony, feedback, and input to the Board? Are you comfortable with a two or three minute limit on public input?

3) Given your understanding of the role and responsibilities of a member of the Board of Education, why do you believe that you are qualified for the position?

Respectfully, liking children, being a public school graduate, or having been involved in education is not the same as taking on the role of a major policy board. HEPC encourages the Committee to focus on the role as board member, and perhaps the candidate's understanding of why this is fundamentally different than being a teacher or a principal. Candidates should be able to articulate the differences.

4) What do you hope to accomplish during your term of service?

HEPC encourages evidence that the candidates wants to go being "being" a member, to specific goals and a sense of what a successful term would look like.

5) Name three qualities that best describe you and that would make you stand out. How would these qualities benefit the Board of Education?

HEPC suggests the answers that best reflect knowledge, commitment, decisiveness in making hard decisions, and respecting all the legitimate stakeholders and views.

6) Name one previous experience that would make you stand out. How would this benefit the Board of Education?

Hopefully, candidates will have served on a major board or commission so that the learning curve is not one of context or process.

I am an Associate Professor and Chair of the Department of Educational Administration at the University of Hawaii at Manoa. I am submitting testimony in support of the nomination of Dr. Carmielita Minami to represent Hawaii on the Education Commission of the States. I have known Dr. Minami for nearly 24 years as a colleague, a leader in education in the Hawaii Department of Education, a doctoral student, a scholar, and a friend. When I met her, she was principal of Salt Lake Elementary School and was also a mentor to a candidate in the DOE leadership preparation program. After she left that position, she worked in the Professional Development and Educational Research Institute (PDERI), where she lead the principal preparation program for a number of years. Because I have worked closely with that program since coming to UH Manoa in 1992, I got to know Dr. Minami very well on a professional level. She was an expert and very adept as a leader in practice, but she was also very in the research and theory underlying best practices. She showed an interest in pursuing her Ph.D. in the UH Manoa College of Education and I fully encouraged her to, having full confidence in her ability to develop and contribute as a scholar in the field. She completed the Ph.D. program in 2013, writing an excellent dissertation analyzing narratives on leadership practices and actions of novice school leaders.

I believe Dr. Minami would be an outstanding representative from Hawaii on the Education Commission of the States. She has been an education professional and leader in education for over forty years, remaining active even after her retirement.
