6 limited to pharmacological, medical, community and business affairs, youth action, educational,

- 8 2 of the Hawaii Revised Statutes.
- 9 Ms. Johnson earned a Bachelors in Psychology and Masters of Science in Counseling
- 10 Psychology from Chaminade University and is a Licensed Marriage and Family Counselor,
- 11 Certified Clinical Supervisor, and Certified Substance Abuse Counselor. She is the Acting
- 12 Director of the Substance Abuse Counseling Center (SACC) on the Kaneohe Marine Corps Base
- 13 of Hawaii, which provides comprehensive screenings and assessments, referrals, prevention
- 14 services, early intervention and education, treatment coordination, case management, individual
- 15 treatment and support, couples/family counseling involving substance use/addiction, transition

1	and aftercare, training and outreach services. Prior to assuming her current position as Acting
2	Director for the SACC, Ms. Johnson served as Lead Counselor, acting Licensed Independent
3	Practitioner and Substance Abuse Counselor for the SACC. Her appointment to represent the

- (1) Why do you want to be a member of the Board? I have a desire to serve on the Board to be an active part of change. With the continuously evolving communities, environment, social norms, and economy of Hawai'i, I believe that it is important to connect with others in an interdisciplinary setting to discuss the common/current trends of what's interfering with the overall well-being of our people, and the possible solutions that can make a positive impact on future outcomes.
- (2) What do you perceive are the roles and responsibilities of a member of the Board? I think that the roles and responsibilities a Board member has are to represent/be the voices of our indigenous communities, current Hawai'i residents, and the people of our state. A Board member should be knowledgeable of the existing social issues/concerns that surround substance use/misuse/abuse, and work together to find possible solutions to reduce the negative impact it has and can have in our state, our communities, our homes, our families, our schools, etc.
- (3) In what ways do you feel that you can help protect the consumer? I feel that I can protect consumers by both providing and taking away shared information, and suggesting, encouraging, and/or implementing changes within the community that I serve. I believe that protection is best displayed through awareness and increased knowledge, which I hope I will be able to offer to others as I learn from my experiences and interactions with those on the Board.
- (4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board. I feel that I am qualified for the position because of my ability to work well with others, to set realistic and achievable goals for change, to be imbedded and have relationships with the population I serve, to be unafraid to speak on behalf of those who have no voice, and my desire to do what's best for the whole.
- The experiences that I've had working with a variety of people (that differ in age, religion, ethnicity, economic status, academia) in different settings (school, home, church, residential treatment program, recovery community, military base) has molded my perceptions to be what they are today, which I believe would be an asset to the Board. I have had the honor to assist individuals, couples, and families by providing clinical, spiritual, treatment, early intervention, prevention,

and resource services. I am organized, thought provoking, solution focused, detail oriented, hard-working, hopeful, goal focused, objective, and fair in the way I process information and implement change. I enjoy learning from others and working towards a common goal, while encouraging relationships built on trust, honest communication, and validation.
