- Why do you want to be a member of the Board?
 I would like to be a member of the Board to contribute my knowledge and somewhat unique perspective as a pediatrician and addiction medicine provider on the Island of Kauai. I would like to be able to contribute to improving the serious addiction problem and lack of resources that exist here on Kauai.
- What do you perceive are the roles and responsibilities of a member of the Board?
 I believe the roles and responsibilities of the members of the board are to evaluate and integrate information that we are given regarding substance abuse and addiction in Hawaii and to present opinions and recommendations to the governor.
- (3) In what ways do you feel that you can help protect the consumer? I believe that in finding ways to improve the substance abuse problem in Hawaii we would be helping protect consumers not only from a safety perspective but also from a financial perspective. I believe that an improvement in the substance abuse and addiction problem in Hawaii would improve the quality of life for all of its residents.
- (4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I am qualified for this position because I face issues regarding substance abuse and addiction on a daily basis in my practice as a pediatrician because of the effects of drug abuse and addiction on many of the children in my practice. Additionally, I have a small addiction medicine practice to provide medication-assisted treatment to those wishing to be free of opiate addictions.

I have been a pediatrician for 16 years and in that time I have had several opportunities to observe the effects of drug and alcohol addiction on families . Shortly after moving to Kauai, The size of the drug addiction problem it became very apparent to me and I knew that I wanted to help in some way. I was encouraged by colleagues to consider obtaining a suboxone license in order to contribute to decreasing the opioid addiction problem on our island.

I believe that my knowledge in both of these areas can bring a unique perspective to the Board.

- (5) What do you hope to accomplish during your term of service? I hope to accomplish improving support for a treatment facility on the island of Kauai and to help this become a reality. I would also like to find a way to improve access of care to those requiring mental health and substance abuse care, as this is a huge problem on Kauai.
- (6) Name three qualities that best describe you and how these qualities will benefit the Board.

Three qualities that best describe me are honest compassionate and tenacious. In being honest I will share what my true feelings and opinions are with the Board, which hopefully will be helpful in coming to consensus opinion. In being compassionate I truly understand and feel the difficulties that members of our community have with this very taboo issue about which we must speak very frankly and openly. In being tenacious if I have a goal and a job to do I will not stop until it is done. I believe all of these qualities will benefit the Board.

- (7) Name a previous experience you've had that will be beneficial as a Board member.
 I was the pediatric department chair and perinatal co-chair for approximately 3 years at KVMH. I believe this position gave me a lot of experience in leadership, in being a team player and in helping to organize the team. I believe this experience will benefit me as a Board member.
- (8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest? I do not foresee any conflicts of interest which may arise during my service on the board however I understand that we are unable to see the future. If I felt that I had a conflict of interest I would make every effort to wait each issue and determine a best course of action.
