To review the qualifications of applicants for licensure and to adopt rules designed to maintain a high standard of licensing for the protection of the consumer.

(3) In what ways do you feel that you can help protect the consumer?

In conjunction with Regulated Industries Complaints Office (RICO), the Board decides on disciplinary action against licensees including fine, suspension, or revocation for any violation of the licensing law or rules of the Board.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

With a true understanding on how businesses work in conjunction with financing, I have been able to broaden my expertise to the management of people, as the manager of the Commercial Markets division at American Savings Bank, and externally utilizing a quality network of business associates to connect people to generate business and help the community.
