Aloha kākou, I write to express my **strong support** for the nomination of Neil Hannahs for the State Commission on Water Resource Management. I am the director and senior professor at the Kamakakūokalani Center for Hawaiian Studies, at the University of Hawai'i at Mānoa, but I submit these comments as a private person.

I have known Neil for the past 50 years. We were high school classmates together at Kamehameha and we both went to off to university. We both have worked for educational institutions for most of our careers. However, whereas my career has been at university teaching Hawaiian Ancestral Knowledge, Neil's career has been devoted to culturally-based land and water resource management for the largest land owner in Hawai'i, the Kamehameha Schools Bishop Estate.

In essence, he has taken the knowledge of our ancestors and applied that to the modern challenges facing Kamehameha in ensuring that their lands are managed in support of its important educational mission. As the former manager of Kamehameha Schools' agricultural and conservation lands [358,000 acres], Neil possesses 40 years of experience in balancing Western and traditional water resource management. He excels in looking at the needs of all and will be a great asset to the Water Commission's consideration of the many private and public water needs.

Before serving as the Director of Strategic Integration in Land Assets, where he was responsible for managing the Schools' agricultural and conservation lands, he had previously worked as the Kamehameha Region II Director, where he managed 50,000 acres of land on Kaua'i, Maui, Moloka'i and in Windward O'ahu. Water management on all of those lands are critical to both Kamehameha Schools as well as to all the people of Hawai'i.

Throughout his entire career at Kamehameha, Neil was the principal spokesman for integrating Ancestral Knowledge practices into the Schools' land management models and policies. He led in the development of Natural and Cultural Resource Management Plans, and most importantly culturally–appropriate watershed management partnerships. His team made possible the very popular stewardship programs that allowed the community to use Kamehameha land assets for cultural, economic, environmental and educational benefits. These assets include hundreds of acres of Hawaiian fishponds that have become so important to the Hawaiian community.

Of course his stellar career in managing the land and water for the largest land owner in Hawai'i has given Neil invaluable experiences directly relevant to the Water Commission's mission of overseeing the management of our public trust water resources. Moreover, Neil volunteers on many non-profit boards in support of the Hawaiian community, with a Native Hawaiian and 'āina focus. Besides chairing the Polynesian Voyaging Society board, he also has served on the boards of the Kohala Center, the Hawaiian Islands Land Trust, Bishop Museum, and the 'Āina Ulu program, which he also founded.

Neil's extensive experience fulfills the State Water Code's requirement of "substantial experience and expertise in traditional Hawaiian water resource management techniques and in traditional Hawaiian riparian usage." I have no doubt that he will bring great solutions to the many discussions and decision-making with colleagues on the Water Commission and I recommend him to you without reservation.
