Chair Keith-Agaran and members of the Committee, it is my great pleasure to write in support of the confirmation of Dr. J N. Musto as a member of the Hawai'i Labor Relations Board. I can think of no one better qualified to serve on this board than Dr. Musto. He is a proven leader, a strong communicator, a consensus builder, a strategic thinker, and an authority on labor law in general and on Chapter 89 in particular.

I first met Dr. Musto in 1979 when I was a Deputy Attorney General assigned to the University of Hawai'i. Although my role in representing the University administration often put me in an adversarial position with Dr. Musto, our dealings were always professional, collaborative and respectful.
