Chair Baker and Members of the Committee:

I am Tim Lyons, President of the Subcontractors Association of Hawaii and we support this nomination.

As you are well aware, CLB deals with a variety of issues, all of which must be approached with fairness and equity in mind. We find that Mr. Kagawa has done exactly that.

It's an opportunity to participate in the functions of government while using the knowledge and experience of my occupation.

I've worked in the construction industry for 35 years and have participated in the construction of commercial building, condominiums, hotels, hospitals and industrial piping projects. I've been exposed to the training requirement as a member of the Honolulu Joint Apprenticeship and Training Committee for the Plumbing & Pipe Fitting Industry and am aware of the level of training and skill needed to accomplish work in that trade and can extend that awareness to other trades.

(5) What do you hope to accomplish during your term of service?

To help craft changes to the licensing statutes that will bring the statutes in line with the current building and construction practices.

(6) Name three qualities that best describe you and how these qualities will benefit the Board.

1. The analytical side of me tells me that we should gather all the available information to make a good decisions.
