Dear Senator Gabbard:

Thank you for your invitation to provide information regarding my nomination to serve as a Commissioner of the Land Use Commission of the State of Hawaii.

I am honored to be nominated by Governor David Y. Ige and I appreciate this opportunity to provide you the following about myself and my views about service as a commissioner.

I. SUMMARY STATEMENT

In 1978, during my senior year at the University of Hawaii, I was fortunate to serve on the staff of Masu Dyer, a delegate to the 1978 Constitutional Convention.

To this day, I appreciate that Delegate Dyer hired me, because she allowed me to serve on her staff although I had to leave before the end of the Convention, to attend law school at the University of California, Davis.

Based on my experience at the Constitutional Convention, I know that the Hawaii State Constitution reflects our shared community values which makes Hawaii uniquely our home.

The 1978 Constitution was a product of a broad based community discussion. The delegates who drafted the Constitution were elected to the Convention by their neighbors.

Except for two delegates, none were incumbent legislators. Many legislators, in fact, publicly stated they would not seek election as a delegate, so that the Constitutional Convention would unquestionably reflect the will of Hawaii's citizens, and not necessarily the decisions of sitting legislators.

Many constitutional amendments were proposed, discussed in open meetings where the public was encouraged to attend and participate; proposed amendments were debated by the delegates and many proposals discarded or modified.

The final product, the Hawaii State Constitution of 1978, was approved by the Delegates and ratified by the voters of the State of Hawaii.

This deliberative process demonstrates the depth Hawaii's constitution reflects our common values, our common experiences and our common heritage. It embodies the consensus of our friends, families and neighbors, who are of all ethnicities, cultures and origins.

The Hawaii State Constitution communicates a vision and hope for future generations, and of those of us who call Hawaii home.

These important, common values include the Public Trust Doctrine, stated as follows in Article 11, Sec. 1:

Const. Art. 11, § 1

For the benefit of present and future generations, the State and its political subdivisions shall conserve and protect Hawaii's natural beauty and all natural resources, including land, water, air, minerals and energy sources, and shall promote the development and utilization of these resources in a manner consistent with their conservation and in furtherance of the self-sufficiency of the State.

All public natural resources are held in

trust by the State for the benefit of the people.

Article 11, Sec. 3 of the Hawaii Constitution expressly protects agricultural lands:

Const. Art. 11, § 3

The State shall conserve and protect agricultural lands, promote diversified agriculture, increase agricultural self-sufficiency and assure the availability of agriculturally suitable lands. The legislature shall provide standards and criteria to accomplish the foregoing.

Lands identified by the State as important agricultural lands needed to fulfill the purposes above shall not be reclassified by the State or rezoned by its political subdivisions without meeting the standards and criteria established by the legislature and approved by a two-thirds vote of the body responsible for the reclassification or rezoning action.

The affirmation and protection of native Hawaiian cultural practices is stated in the Constitution as follows:

Const. Art. 12, § 7

The State reaffirms and shall protect all rights, customarily and traditionally exercised for subsistence, cultural and religious purposes and possessed by ahupua'a tenants who are descendants of native Hawaiians who inhabited the Hawaiian Islands prior to 1778, subject to the right of the

State to regulate such rights.

These provisions of the Constitution of the State of Hawaii are not simply a concern of a specific portion of the community, a specific ethnic or cultural group, or persons of a specific political ideology. The Constituion was a product of elected delegates, representing a wide cross-section of the people who call Hawaii home, and was duly ratified by Hawaii's voters, who likewise comprised a wide cross-section of Hawaii's citizens.

As a result, the Hawaii Constitution is a reflection of the consensus of Hawaii's citizens and a statement of their common community of values and beliefs.

If confirmed, I promise to follow the law, without bias in favor or against anyone appearing before the Land Use Commission. I promise to make decisions based solely on the evidence presented to the Commission, and according to the statutes passed by the legislature and the administrative rules adopted by the Commission pursuant to legislative authority. I promise to keep an open mind. I promise to be guided by the provisions of the Hawaii Constitution.

II. MY BACKGROUND

I was born in 1956 at Kapiolani Hospital in Honolulu, Hawaii, the eldest of three children of Robert and Setsuko Okuda.

My father was from a family of 8 siblings from Hilo, Hawaii where my grandfather Asataro Okuda worked on the docks before the days of union protection. My mother's family of 9 siblings grew up in Kalihi; my grandfather Sadame Awaya was the chauffeur for former Territorial Governor George Carter.

I do not view the "plantation days" with nostalgia. Those days were filled with inequality, the lack of opportunity, and two World Wars.

My father was a trained bookkeeper and retired from his work in the construction industry. Growing up, my mother stayed at

home to raise myself and my two sisters, but went back (after my youngest sister was older) to the retail business where she worked before I was born.

I grew up in Coconut Grove, Kailua, long before Kailua became a tourist destination; my father and mother still live on the same property my father first purchased before the Pali Tunnels were built.

I graduated from Kailua High School, Class of 1974, and then attended Windward Community College. I transferred to the University of Hawaii at Manoa where I received in 1978 my B.A. degree in political science. My first trip to the Mainland was to attend law school and I received my law degree from the University of California at Davis in 1981.

From 1981 through 1987, I practiced law with the firm Okumura Takushi Funaki & Wee. Since 1987, I have practiced with my own firm, now known as Leu Okuda & Doi.

My spouse Marlyn Okuda is a Special Education teacher. She has taught on Molokai, and various Windward district schools. Although she retired from the Department of Education, Marlyn still regularly substitute teaches, primarily at Palolo Elementary School.

Our 30 year old daughter Yoko is a graduate of the University of Hawaii at Manoa and works with autistic children at Easter Seals. Our 27 year old son Don is a graduate of Otis College of Art and Design in Los Angeles, California, and works as a product designer with the technology company Github in San Francisco, California.

My resume is attached to this letter, which summarizes my education and work experience.

III. RESPONSES TO SPECIFIC QUESTIONS.

"(1) <u>Why do you wish to be a member of the Land Use</u> Commission?"

After its people, land is one of the most precious resources of Hawaii. How land is used affects Hawaii's other resources, its air, its water, and the quality of life of its people.

Land use affects Hawaii's economy, and determines where, how and the conditions under which Hawaii's people live.

In some instances, the process by which land use decisions are made affects the people's trust in their government.

I wish to contribute to the stewardship of the land, consistent with the mandates set forth in Hawaii's Constitution, by strictly adhering to the statutes passed by the Legislature, and implementing all statutes by following the practice and procedures set forth in the Hawaii Administrative Rules.

I recognize that the challenges facing Hawaii are many, and the solutions are not simple. For example, successful, sustainable agriculture involves more than simply designating a parcel of land for agriculture; it involves the availability of water, infrastructure, consideration of labor and other production costs, the training and experience of the farmer and farm workers, and ultimately the existence of a market that will turn a profit for the agricultural product being grown.

I wish to be a Land Use commissioner because I can contribute to making decisions based on the evidence, in a quasijudicial proceeding.

Land use decisions will probably best result from simply adhering to the stated requirements of the law. By doing so, decisions will more likely than not be made based on the merits, and not on bias, prejudice or secret agendas.

"(2) <u>How do you perceive the role and responsibilities of a</u> member of the Land Use Commission?"

If confirmed, I perceive my role to make decisions based solely on the evidence presented to the Commission, in strict compliance with the procedures and provisions set forth in the Hawaii Administrative Rules, the applicable statutes, and guided

by the community values stated in the Hawaii Constitution.

I perceive my role to make these decisions with an open mind, free from bias, prejudice or favoritism.

I perceive my responsibility to engender trust in government and the land use process. To that end, I recognize that conflicts of interest, actual or perceived, must be avoided.

"(3) <u>Given your understanding of the role and</u> responsibilities of a member of the Land Use Commission, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid in your decision-making ability as a member of the Land Use Commission."

My education, professional training and experience has prepared me to participate in the quasi-judicial process followed by the Land Use Commission.

My law practice has included a significant amount of trial and motion practice, where decisions are focused on applying the provisions of the statutes passed by the legislature to the evidence admitted during a judicial proceeding.

After practicing law for almost 35 years and having my presentations in court being scrutinized and challenged by many of Hawaii's very qualified trial judges, I understand the importance of strictly following the mandates of the legislature and carefully scrutinizing the arguments and evidence presented by parties.

"(4) <u>What do you hope to accomplish during your term of</u> service?"

I hope to treat with fairness and dignity all persons that appear before the Land Use Commission.

I hope to faithfully follow and apply the requirements of the Hawaii Constitution and the statutes enacted by the legislature, to all matters requiring a decision by the

Commission, and strictly following the Hawaii Administrative Rules applicable to the Commission.

I hope to be fair, open-minded, and free from bias or prejudice.

"(5) <u>Name three qualities that best describe you and that</u> would make you stand out. How would these qualities benefit the Land Use Commission?

I will keep an open mind.

I will follow the law.

I will work hard.

I hope that these qualities will assist the Land Use Commission in making timely decisions, consistent with the requirements of the law.¹

§ 205-17. Land use commission decision-making criteria

In its review of any petition for reclassification of district boundaries pursuant to this chapter, the commission shall specifically consider the following:

(1) The extent to which the proposed reclassification conforms to the applicable goals, objectives, and policies of the Hawaii state plan and relates to the applicable priority guidelines of the Hawaii state plan and the adopted functional plans;

(2) The extent to which the proposed reclassification conforms to the applicable district standards;

(3) The impact of the proposed reclassification on the following areas of state concern:

(A) Preservation or maintenance of important natural systems or habitats;

(B) Maintenance of valued cultural, historical, or natural

¹ I recognize that the Commission has an obligation to consider many factors and all relevant facts in making its decisions, and these decisions must be made based on the evidence, presented in a quasi-judicial format or proceeding. See, H.R.S. Sec. 205-17 which provides:

"(6) <u>Name one previous experience that would make you stand</u> out. How would this benefit the Land Use Commission?"

My law partners and I have been willing to refuse to take actions on behalf of clients, where, in our professional judgment reached after investigation and research, we concluded that such action would be contrary to the law and our oaths as officers of the Court. We refuse to take actions contrary to law, even when threatened with the loss of significant business, and those threats were actually carried out.

I hope I will continue to have the backbone to do what is right and lawful, thereby benefitting the Commission.

"(7) Can you foresee any possible conflicts of interests

resources;

(C) Maintenance of other natural resources relevant to Hawaii's economy, including agricultural resources;

(D) Commitment of state funds and resources;

(E) Provision for employment opportunities and economic development; and

(F) Provision for housing opportunities for all income groups, particularly the low, low-moderate, and gap groups;

(4) The standards and criteria for the reclassification or rezoning of important agricultural lands in section 205-50;

(5) The county general plan and all community, development, or community development plans adopted pursuant to the county general plan, as they relate to the land that is the subject of the reclassification petition; and

(6) The representations and commitments made by the petitioner in securing a boundary change.

Housing is expressly a category required by H.R.S. Sec. 205-17(2)(F) to be considered in a rezoning decision, and available supply of housing may affect price.

However, if agriculture in Hawaii is to be preserved, nurtured and developed, the rezoning of agricultural lands must be done very carefully and scrutinized according to the standard of review required by law.

that could arise during your service on the Land Use Commission? How would you overcome any possible conflicts of interest?"

I do not foresee conflicts of interest.

Our law firm has an established practice going back to 1987. Much of our practice involves representing mainland lenders and established local businesses and clients, who generally do not have matters before the Land Use Commission.

We do not represent clients seeking Land Use Commission approvals or persons opposing actions pending before the Land Use Commission. I am not aware of any client of the firm with matters pending before the Land Use Commission, or likely to present a matter before the Land Use Commission.

If I am confirmed, Our firm will not represent persons or entities with matters before the Land Use Commission. We will use our standard computerized conflict checking procedure (which we use with all our other client matters) to prevent conflicts of interest.

If either an actual conflict or the appearance of a conflict of interest arises, I would recuse myself from the matter. I will also take whatever additional actions are reasonable or necessary to insure public confidence and trust in the Land Use Commission, even if such additional actions exceed more than recusal.

Although not required at this time, I attach to this letter a disclosure of my finances, in the form required by the State of Hawaii of confirmed commissioners. I disclose all the assets and debts of myself and my spouse, including those items not usually required to be disclosed.

My spouse Marlyn and I are providing this advance disclosure, so that you and the public may determine whether I may be subject to any financial pressure by any person, entity, industry or group.

Since being nominated by Governor Ige, I have not accepted gifts from anyone, including the local style practice of friends picking up the tab and paying for lunch.

I intend to continue declining gifts, even if such gifts would not violate any law or rule applicable to Land Use commissioners.

I also disclose that I am representing the Plaintiffs in the following cases against the State of Hawaii, which do not involve the Land Use Commission:

A. <u>KITSU V. DEPARTMENT OF EDUCATION</u>, Civil No. 15-1-1824-09 GWBC.

I am one of the attorneys representing Susan Kitsu, the former director of the Department of Education's Civil Rights Office, in a wrongful termination action.

B. <u>ARTHUR V. DEPARTMENT OF HAWAIIAN HOME LANDS</u>, Civil No. 05-1-1981.

I am one of the attorneys representing the Plaintiff in a wrongful death action.

C. <u>OCEANIC KAIMAMALA CORP., NEPHI OHAI, LEO OHAI, and</u> <u>VIRGINIA OHAI, vs. STATE OF HAWAII, STATE OF HAWAII</u> <u>DEPARTMENT OF PLANNING AND ECONOMIC DEVELOPMENT AND ITS</u> <u>SUCCESSOR ENTITIES</u>, Civil No. 01-1-2505-08 KSSA, and <u>LEO OHAI and NEPHI OHAI vs. STATE OF HAWAII</u>, Civil No. 09-1-0208-01 KKS.

I am the attorney representing Plaintiffs Ohai in an action arising out of a loan with the State of Hawaii. We are waiting for confirmation of approval of a settlement of the case.

D. <u>GARY OKUDA V. DEPARTMENT OF EDUCATION</u>, Civil No. 15-1-1789-09 VLC

This is a lawsuit I filed to enforce a request for procurement and other documents from the Department of

Education. Upon confirmation, I will withdraw from the case and will be substituted as Plaintiff by another person.

For each of these cases, I will request an opinion from the Ethic's Commission on what actions I should take, if I am confirmed as a Commissioner.

IV. CONCLUSION.

I am honored by the nomination of Governor Ige to serve the people of Hawaii as a Commissioner to the Land Use Commission.

If confirmed, I pledge to keep an open mind, and make decisions without favoritism or bias.

I will do so by acting in accordance with the Hawaii Administrative Rules, by adhering to the statutes passed by the Legislature, and by being guided by the Hawaii State Constitution, which sets forth the common goals, values and heritage of all of Hawaii's people.

I am Sharon Moriwaki, Associate Director of the University of Hawaii Public Policy Center and Co-chair of the Hawaii Energy Policy Forum. I have also served as the principal investigator for the Hawaii 2050 Sustainability Plan (2008-11) and worked with Hawaii Green Growth to put the sustainability priority guidelines into the Hawaii State Plan ("State Plan").

The State Plan has served as a guide to ensure that the vision and goals continue to guide Hawaii to preserve, enhance and ensure that our precious natural resources are not depleted but instead sustains future generations.

This is why the Land Use Commission was created. It should be led by those who hold our land and resources as sacred, with use designations revised only when necessary for the public interest. Board members must have the character, experience, knowledge, commitment and foresight to preserve our natural resources for the long-term.

Today we face great competing demands – affordable housing, schools, hospitals, streets and roads, etc. -- that require commissioners who can listen carefully to all stakeholders, analyze the short and long-term impacts of decisions, and come to fair decisions that will to the greatest extent possible meet the current need without compromising the ability of future generations to meet their needs.

I have worked with Gary Okuda for the past couple years on various projects, including Kaka'ako's overdevelopment. In our discussion he has continued to counsel on what is fair and he has been conscientious in seeking *pono* solutions. I know he is committed to apply the law fairly, to hearing all parties and interests, and deciding in the public interest. In his law practice and community service, he has demonstrated his legal abilities, good judgment and sound ethics. I believe he would make an excellent commissioner and ask that the Senate consent the nomination of Gary Okuda to the Land Use Commission.
