#### In consideration of GOVERNOR'S MESSAGE 878 SUBMITTING FOR THE CONSIDERATION AND CONFIRMATION TO THE ISLAND BURIAL COUNCIL, ISLANDS OF KAUAI AND NIIHAU, GUBERNATORIAL NOMINEE, RICHARD NESMITH FOR A TERM TO EXPIRE 6-30-2017

The Department of Land and Natural Resources (Department) supports Governor's Message 878, nominating Mr. Richard Nesmith to the Island Burial Council, Islands of Kauai and Niihau expiring June 30, 2017.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. With regard to previously known burials, the Burial Councils determine whether to leave the burial in place or remove it, recognize lineal and cultural descendants and provide counsel and advice to the Department.

Mr. Nesmith has a Ph.D. in applied linguistics from the School of Maori and Pacific Development, University of Waikato, New Zealand. He also holds a Master of Arts in Pacific Islands Studies from the University of Hawaii at Manoa and a Bachelor's in Hawaiian Studies. He is currently self-employed (co-founder of organization) working for Na Hoku Welo, LLC., a company that provides consulting services to businesses, community organizations, schools, and government entities regarding the implementation, integration, utilization, and preservation of Hawaiian culture and language in their services, curricula, practices, and products. He has over 20 years of experiencing teaching Hawaiian language, literature, and culture. He is fluent in Hawaiian, English, Tahitian, French, and Marquesan.

Senate confirmation will ensure that Mr. Nesmith's knowledge and perspective informs the deliberations of the Island Burial Council until June 30, 2017.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> GM878, which confirms OHA nominee Richard "Keao" Nesmith as the Waimea/Nāpali regional representative to the Kaua'i and Ni'ihau Island Burial Council.

Born in Waimea and raised in Kekaha, Mr. Nesmith also has 'ohana ties in Anahola and kūpuna in Halelea and Nāpali. Mr. Nesmith was raised with strong Hawaiian traditions, from an early age helping his 'ohana preserve heiau and farm using traditional agricultural methods. His parents further instilled in him a value for preserving historical sites and artifacts, through their frequent participation in archaeological surveys and excavations throughout Kaua'i. Later in life, Mr. Nesmith studied iwi preservation practices with archaeologists, kūpuna, and cultural experts from Kaua'i and elsewhere, and has been personally involved in the discovery, study, curation, and reinterment of iwi kūpuna. Currently, Mr. Nesmith serves as the president of Ka Pua Hipalo o Po'oku, a nonprofit organization focused on the preservation and restoration of the Po'oku Heiau complex in Halele'a. He is also a member of Nāpali Coast 'Ohana, which preserves and restores cultural sites of Nualolo Kai and other areas of Nāpali, and Hui Mālama o Kāneiolouma, which maintains and restores the Kāneiolouma Heiau complex in Po'ipū.

Mr. Nesmith, therefore, has a lifetime of experience studying, maintaining, and restoring traditional and cultural sites, experience that would make him an invaluable member of the Council, should he be confirmed.

For these reasons, OHA urges the Committee to **PASS** GM878, to confirm Mr. Nesmith to the Kaua'i and Ni'ihau Island Burial Council. Mahalo for the opportunity to testify on this important measure.
