Mr. Blake is the Executive Director of Malama Koloa, an organization that seeks to protect, preserve and perpetuate Hawaii's natural and cultural resources. His family is from the Koloa area and goes back 65 generations. In addition, he is a member of the Royal Order of Kamehameha, an organization whose representation on any Burial Council is appropriate.

Senate confirmation will ensure that Mr. Blake's knowledge and perspective informs the deliberations of the Kauai Niihau Islands Burial Council until June 30, 2016.
