# HB 1086 - RELATING TO THE ENVIRONMENT

Chair Lee, Vice Chair Lowen, and members of the House Committee on Energy and Environmental Protection, we respectfully submit testimony in <u>support</u> of HB 1086, which requires the Legislative Reference Bureau (LRB) to update the economic and environmental costs component of its 2002 study on invasive species, and makes an appropriation for that purpose.

Invasive species pose significant threats to agriculture, natural resources, and human and animal health and well-being in Hawai'i. A recent study by the Department of Agriculture reported an average of 24 new insect species introduced to Hawai'i each year. In addition, invasive plant species threaten our native forests (e.g., miconia), and animal health (e.g., fire weed). Many of the resources of the University of Hawai'i, particularly in the College of Tropical Agriculture and Human Resources (CTAHR) and the Pacific Cooperative Studies Unit (PCSU) at the University of Hawai'i at Mānoa, are dedicated to combating these threats.

As a member of the Hawai'i Invasive Species Coordinating Council, the University of Hawai'i supports the actions recommended in HB 1086. The 2002 study of the impact of invasive species in Hawai'i performed by the Legislative Reference Bureau has provided a solid basis for state action for over a decade, but needs to be updated to reflect the current situation.

Thank you for the opportunity to testify in support of HB 1086.

1 **Office Testimony:** The Office of Environmental Quality Control (OEQC) supports the intent of

2 HB 1086, which requires the Legislative Reference Bureau to update its 1985 study on

3 environmental reorganization for Hawai'i and recommendations of the 1992 department of

4 environmental protections task force, and funds to support the measure.

5 The disjointed nature of environmental management, as described in HB 1086, merits a 6 reevaluation of the current system and its practical implications with respect to the state's 7 response to the various environmental issues today, including for example, climate change, 8 energy, food security, water resource management, and invasive species. An update to the 9 LRB's 1985 study can be a helpful tool to identify how different agencies and programs can be 10 consolidated to cohesively, efficiently and effectively address the state's environmental 11 management and protection strategy.

13 Governor's Executive Budget Request for fiscal priorities.

Chair Lee and Members of the Committee:

Good morning Chair Lee and members of the Committee, my name is Charlotte Carter-Yamauchi and I am the Acting Director of the Legislative Reference Bureau. Thank you for providing the opportunity to submit written comments on H.B. No. 1086, Relating to the Environment.

The purpose of this bill is to:

- (1) Require the Legislative Reference Bureau to update its 1985 study "The Feasibility of Environmental Reorganization for Hawaii" and assess the feasibility of implementing the findings and recommendations of the Department of Environmental Protection Task Force.
- (2) Authorizes the Bureau to contract the services of another entity, without regard to the procurement requirements of Chapter 103D, Hawaii Revised Statutes, to provide services related to the performance of the update;
- (3) Appropriate moneys to the Bureau for the contract.

While the Legislative Reference Bureau takes no position on this measure, we submit the following comments for your consideration.

The Bureau believes that the update requested under this measure, as presently drafted, is manageable and that the Bureau will be able to provide the update in the time allotted; provided that the Bureau's interim workload is not adversely impacted by too many other studies or additional responsibilities, such as conducting, writing, or finalizing other reports, drafting legislation, or both, for other state agencies, task forces, or working groups that may be requested or required under other legislative measures.
