HOUSE BILL NO. 1138 RELATING TO ALBIZIA TREES

Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to testify on HB 1138. The purpose of this bill is to appropriate moneys from the pest inspection, quarantine, and eradication fund for the removal of Albizia trees from public and private land. The department respectfully opposes this measure.

Chapter 68 (HAR) gives the department the authority to control and eradicate weeds by designating them as noxious weeds if they meet specific criteria. This rule gives the authority to the department to enter into cooperative agreements with landowners to control or eradicate weeds on their property. Once controlled or eradicated the weeds are to be removed from the list.

The department considers Albizia a serious weed pest but has not placed it on our list for control or eradication because it does not meet the criteria in the rules for eradication as described in chapter 68. Our strategy is to address this problem through our biocontrol program. Albizia is one of our target biocontrol species and we have begun discussions with potential partners to find effective natural enemies for this tree. There have been no attempts throughout the world to control Albizia so this is breaking new ground and will be a long-term project.

A comprehensive plan and authorities for Albizia control could be appropriately developed through the Hawaii Invasive Species Council (HISC). Albizia is a widespread problem throughout the state and will require a multi-agency approach. HISC is ideally suited for this and was established for this purpose. HISC is drafting administrative rules and, if appropriate, Albizia should be added to their list of invasive pests. A listing



under the HISC rules would give authority to HISC partners to enter private property for control and eradication purposes.

House Bill 1138 proposes to appropriate an unspecified amount of special funds from the Pest Inspection, Quarantine, and Eradication Fund for the control of albizia trees on public and private property. The Department of Land and Natural Resources (Department) offers the following comments.

The Department recognizes the environmental and public safety threats posed by the invasive tree *Falcataria moluccana*, commonly known as albizia, and supports control of albizia where possible. The Department understands that the interagency Hawaii Invasive Species Council, which is administratively housed within the Department and includes the Hawaii Department of Agriculture (DOA) as a co-chair, is working with the Big Island Invasive Species Committee on a plan for strategic albizia control, and that other measures in this legislative session propose appropriations from the general revenues of the State of Hawaii for albizia removal.

The Department defers to DOA on how an appropriation from the Pest Inspection, Quarantine, and Eradication Fund would impact the ability of the Fund to address the issues for which it is currently mandated.

House Bill No. 1138 – Relating to the Albizia Trees

Chair Clift Tsuji, Vice Chair Richard Onishi, and Members of the Committee,

My name is Jay Ignacio and I am testifying on behalf of the Hawaiian Electric Company and its subsidiaries, Hawai'i Electric Light Company and Maui Electric Company (collectively, the "Hawaiian Electric Companies") in support of HB 1138.

HB 1138 would appropriate funds to the Department of Agriculture for the removal of albizia trees on public and private land. Under the direction of the Hawaii Invasive Species Council, management and removal of albizia trees in critical emergency services and transportation routes have been identified. The Hawaiian Electric Companies support the bill for the following reasons:

- Albizia trees are a hazard to public safety and critical infrastructure.
- Stands of brittle, invasive Albizia trees up to 250 feet tall grow along many roadways, highways, and electric utility lines statewide. Tropical Storm Iselle and this past weekend's severe weather brought down many of these trees, blocked roadways, and caused extensive damage to homes and important electric utility lines. Broken tree trunks continue to send out new growth creating even more unstable conditions, while seedlings are rapidly germinating in disturbed areas.
- A coordinated interagency strategy under the direction of Hawaii Invasive Species Council, to remove narrow bands of hazard trees and surrounding source populations of non-hazard trees can prevent similar damage in future storm events, providing substantial net savings in avoided future maintenance costs and ensuring long-term control.
- A strong partnership between agencies and federal, state and county governments is essential to mitigating Albizia hazards and ensuring that Hawai'i's public safety and critical infrastructure needs are met.

Thank you for the opportunity to testify on this matter.

Testimony

I own a house in Hawaiian Beaches, where I have lived since 2009. While my property has been cleared of albizia trees, they are all around my property. After Hurricane Iselle, my back yard had at least 40 albizias in it from the neighbors' yards. It took a month and quite a bit of money to clear those trees from my yard. And, since the neighbors' lots weren't completely cleared, broken trees are piled up 6 feet high on the other side of my fence. The entire block, in fact, looks like a disaster area where trees were snapped off by the wind and left on their sides.

We were without power, telephone, internet and cable service for 2 weeks after Hurricane Iselle, due entirely to the damage wrought by albizias. The first damage on our property with the first gust of wind was the snapping of our power lines by an albizia from the neighbor's lot next door. After the storm was over, our entire street was blocked by fallen albizias, and all of the power and telephone lines were down in our street.

Of course, Kahakai Boulevard was in much worse shape so even if our power lines hadn't come down on our street, we still would not have had power because of the damage to the main lines on Kahakai.

It doesn't take a hurricane, though, to interrupt our power. As I write this, we are still without cable service after the February 14, 2014, high winds. We were without electricity, cable, internet and telephone service for nearly 2 days. Our water company was on generator power during part of that time so we also had to conserve water during that time.

I have lived all over the United States and in Europe, and I have never had the problems with services there that we have here. As soon as the wind picks up on any given day, we know that we are in danger of losing our electricity, telephone, internet and cable.

Please either do something with the albizias so that we no longer have to live this way.

We need to be sensitive to and distinguish between absentee speculative property investors who let unimproved lots turn into albizia nurseries, from the resident poor and elderly who may have financial and/or physical hardship reasons for needing assistance in albizia removal. Let us please not penalize local families in hardship situations, while doing the right thing for the environment and community by removing these dangerous and expensive pests. I would propose giving owners of investment type vacant lots a short but reasonable opportunity to clear and regularly maintain their land (malama 'āina). If this does not occur and their lack of maintenance endangers other properties, infrastructure, or life, then the new program proposed by this legislation should kick in along with some heavy fines and property liens up to and including foreclosure on lots that continue to pose a risk to the community.
