## **RE:** H.B. 1198 – RELATING TO APPROPRIATIONS FOR THE HONOLULU FAMILY JUSTICE CENTER

Chair Espero, Chair Keith-Agaran, Vice Chair Baker, Vice Chair Shimabukuro, members of the Senate Committee on Public Safety, Intergovernmental and Military Affairs, and members of the Senate Committee on Judiciary and Labor, the Department of the Prosecuting Attorney for the City and County of Honolulu ("Department") submits the following testimony in <u>strong</u> support of H.B. 1198, with amendments.

The Honolulu Family Justice Center (HFJC) is a public safety initiative developed by the Department that will provide comprehensive services for victims of domestic violence, sex assault and human trafficking as well as long-term transitional housing. The HFJC will provide victims with a safe environment during some of their most vulnerable stages of separation from their abusers and encourage increased trust and understanding between victims and police and prosecutors, to better facilitate and follow-through on prosecution of these offenses. This, in turn, will help to hold more offenders accountable for their actions, and ultimately decrease incidents of recidivism.

KEITH M. KANESHIRO PROSECUTING ATTORNEY H.B. 1198 would appropriate funds for the HFJC with the condition that the City and County of Honolulu ("City") provide matching funds on a one-to-one basis. The City fully supports the HFJC and has already made a substantial investment in the HFJC. In its FY 2015 Executive Capital Budget, the Honolulu City Council appropriated \$6,220,000 which has enabled the City to purchase a 24-unit, one (1) -bedroom apartment building in Makiki to house the HFJC. For FY 2016, the Department has requested the amount of \$350,000 for the HFJC in as part of its operating budget request to the Honolulu City Council. It is anticipated that the City will continue its support of the HFJC with continued appropriations to fund the operations of the HFJC. Accordingly, the Department has no objection to the matching fund requirement in H.B. 1198.

However, the Department requests that the following amendments be made to H.B. 1198:

- A. <u>SECTION 1</u>: The reference to chapter 42F, Hawaii Revised Statutes, should <u>be</u> <u>deleted</u> as that chapter authorizes grant funding to individuals, private organizations and non-profit organizations but does not authorize funding for government agencies; and
- B. <u>SECTION 1. subparagraphs (2) and (3)</u>: The HFJC will be providing training to HFJC staff including, but not limited to, risk assessment training regarding domestic violence and sexual abuse and trauma as well as evaluation services for victims. The Department would prefer flexibility in the types of training that are provided to the HFJC staff and residents. Accordingly, the Department respectfully requests that the specific enumeration of risk assessment training and evaluation services in Section 1, subparagraphs (2) and (3), be deleted from H.B. 1198.

For the foregoing reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu <u>strongly supports</u> the passage of H.B. 1198, <u>with the amendments as noted</u> <u>above</u>.
