H.B. NO. 1944

A BILL FOR AN ACT

RELATING TO MITIGATION OF HAZARDOUS SITUATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that section 127A-18,
 Hawaii Revised Statutes, authorizes the governor to allow state
 employees, agents, contractors, or representatives to enter
 private property to mitigate situations deemed to be hazardous
 to the health and safety of the public.

6 The legislature also finds that the Hawaii emergency 7 management agency must have authorization and funding for the 8 hiring of designated personnel to oversee the mitigation of 9 hazardous situations program and carry out the duties identified in section 127A-18, Hawaii Revised Statutes. Currently, there 10 11 is no funding available to the Hawaii emergency management 12 agency for the hiring of designated personnel to oversee and 13 administer the program.

14 The purpose of this Act is to provide personnel and funds 15 to the Hawaii emergency management agency in order to effectuate 16 section 127A-18, Hawaii Revised Statutes.

1 SECTION 2. Section 127A-18, Hawaii Revised Statutes, is 2 amended to read as follows: 3 "[+] \$127A-18[+] Mitigation of hazardous situations. (a) 4. Even in the absence of an emergency or disaster, the governor 5 may authorize designated state employees, agents, contractors, 6 or representatives to enter private property at reasonable times 7 to mitigate situations deemed by the governor to be hazardous to. 8 the health and safety of the public; provided that this section 9 shall be applicable only to the following actions: 10 (1) Cutting, trimming, or removing dangerous trees or 11 branches that pose a hazard to other properties; 12 (2)Stabilizing or removing unstable rock and soil 13 hazards; or 14 (3) Cleaning streams and waterways to mitigate or prevent 15 flooding or other hazards; provided further that at least ten days' written notice shall be 16 17 provided to the landowner and to the occupier of the private 18 property of the governor's intention to authorize designated 19 state employees, agents, contractors, or representatives to 20 enter the property to mitigate the hazardous situation; provided 21 further that the landowner or occupier shall be given a

reasonable opportunity to mitigate the hazardous situation
 without assistance of the State before designated state
 employees, agents, contractors, or representatives may enter the
 property.

(b) Written notice sent to the landowner's last known
address by certified mail, postage prepaid, return receipt
requested, shall be deemed sufficient notice. If land ownership
cannot be determined, notice shall be given once in a daily or
weekly publication of general circulation in the county in which
any action or proposed action will be taken.

(c) If entry is refused, the governor may apply to the district court in the circuit in which the property is located for a warrant to enter the premises. The district court may issue a warrant directing the chief of the appropriate county police to assist the governor in gaining entry onto the premises during regular working hours or at other reasonable times.

17 (d) The governor may seek recovery and reimbursement, by 18 appropriate proceedings, of all costs and expenses incurred in 19 the mitigation of a hazardous situation under this section, and 20 any costs and expenses imposed against any landowner shall be a 21 lien upon the landowner's property.

1 (e) The director shall hire a coordinator and a 2 contracting specialist to oversee all aspects of the program and 3 ensure proper fiscal oversight. 4 [(e)] (f) This section shall take effect [only] upon 5 authorization and funding for personnel to administer the 6 program[-] pursuant to Act , Session Laws of Hawaii 2015." 7 SECTION 3. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$ or so much 9 thereof as may be necessary for fiscal year 2015-2016 and the 10 same sum or so much thereof as may be necessary for fiscal year 11 2016-2017 for the director of the Hawaii emergency management 12 agency to establish one coordinator position and one contracting 13 specialist position pursuant to this Act. 14 The sums appropriated shall be expended by the department. 15 of defense for the purposes of this Act. 16 SECTION 4. Statutory material to be repealed is bracketed 17 and stricken. New statutory material is underscored. 18 SECTION 5. This Act shall take effect on July 1, 2015. 19

Chair Takayama, Vice Chair Yamashita and Members of the House Committee on Public Safety:

I am Brigadier General Arthur J. Logan, State Adjutant General and the Director of the Hawaii Emergency Management Agency. I am testifying in **SUPPORT** of House Bill 1344.

This measure provides for the establishment and funding of two positions in the Hawaii Emergency Management Agency (HI-EMA) that will support Act 76 (Chapter 127A-18 of HRS).

Currently HI-EMA support Act 76 activities "out of hide". There is a restriction to use HI-EMA employees who are funded by federal grant money.

HI-EMA provides the following statistics

To date our agency has received 308 complaints about trees that have the potential to cause harm to the public. We have closed 184 cases by contacting the responsible property owner and informing him/her of their responsibility, and they have taken action to remove the threat to public safety. This leaves 124 cases to investigate.

The mitigation of dangerous situations to the public will be better served by the establishment of these two positions.

Chair Takayama, Vice Chair Yamashita and Members of the House Committee on Public Safety.

I am Doug Mayne and I am the Administrator of the Hawaii Emergency Management Agency (HI-EMA). I am testifying in **SUPPORT** of HB 1344.

House Bill 1344 provides for the establishment and funding of two positions to support Chapter 127A, Section 18 of the Hawaii Revised Statutes, commonly referred to as Act 76. This chapter allows the Governor to designate state employees to enter private property to mitigate hazardous situations impacting public safety. The mitigation is limited to hazardous trees, rocks and streams.

The work outlined in HRS 127A-18 / Act 76 is not eligible to be covered by the federal grant that pays for over half of the salaries of HI-EMA employees. I should not be using any of my current employees for this work. To effectively carry out the intent of HRS 127A-18, I need two 100% state-funded positions: an SR24 Civil Defense Planner and an SR13 Contracts Assistant I. Together, these positions will cost approximately \$89,124 per year in salaries. We cannot continue to meet the intent of HRS 127A-18 without these positions.

To date our agency has received 308 complaints about trees that have the potential to cause harm to the public. We have closed 184 cases by contacting the responsible property owner and informing him/her of their responsibility, and they have taken action to remove the threat to public safety. This leaves 124 cases that we must investigate. If these cases involve an immediate threat to public safety, we may need to take action to mitigate.

The legislature provided \$1 million to support this program during the 2014 session. Using this funding, HI-EMA has executed contracts to cut down three of the most dangerous trees at a cost of \$96,000. That leaves over 60 high priority sites, some with multiple trees, to evaluate and mitigate. Our current plan is to hire an arborist to develop a mitigation strategy and then contract with tree trimming companies to implement the mitigation strategy identified. This requires a great deal of travel, program and contract management, and public outreach. I need the two additional positions to carry out the Legislature's intent in keeping the public safe.

Thank you for allowing me to testify in **SUPPORT** of HB 1344.
