Testimony Supporting House Bill 1373. Establishes a working group to formulate a plan for the transfer of all parcels of land contained within the Leahi Hospital campus to the Hawaii Health Systems Corporation.

On behalf of the Hawaii Health Systems Corporation – Oahu Region, thank you for the opportunity to present testimony in support of HB 1373.

In 2013, the legislature appropriated \$1,500,000 towards the development of a Master Plan for the Leahi Hospital campus to determine how best to utilize the Leahi Hospital campus to address the future long-term services and support needs of the community. In 2012, a conceptual rendering entitled "Leahi Campus Master Plan" was developed and encompasses our future vision for the utilization of this property. A copy of the plan is attached hereto and incorporated by reference herein for your perusal.

In order for the proposed projects in the master plan to become a reality, it is essential that the land on which the Leahi Campus is presently situated be consolidated under the jurisdictional control of a single entity – Oahu Region.

Towards this end, the Oahu Region is in accord with the intent and substance of HB 1373 which proposes to establish a working group to develop of a plan to transfer all parcels of land to the Hawaii Health Systems Corporation.

To provide some background information on the land on which Leahi Hospital is currently situated, in 1996, the legislature passed Act 262 which established Section 323F, Hawaii Revised Statutes, which created the Hawaii Health Systems Corporation ("HHSC"). All facilities previously operated by the Department of Health's Division of

Community Hospitals, and the land on which they are situated, were transferred to HHSC. The only exception to this transfer was the land on which Leahi Hospital is presently situated and other adjacent parcels. The Leahi parcel remained under the management and control of the Department of Health.

Subsequently, by executive order no. 3795, dated September 22, 1999, the Leahi parcel and adjacent parcels were transferred to the management and control of the University of Hawaii at Manoa. While the University of Hawaii holds the fee interest in these parcels, HHSC has a master lease for the property which expires in 2025.

In 2006, 2007, 2008, and 2010, the legislature introduced measures, primarily concurrent resolutions, calling for the development of a master plan for the Leahi parcels to rejuvenate the site to better meet the long term care needs of the community.

In 2008, the legislature amended Section 323F, HRS by creating regional system boards and mandated the transfer of facilities and all other assets to the management and control of these regional boards.

HB 1373 – RELATING TO LEAHI HOSPITAL

Chair Belatti, Vice Chair Creagan, and members of the committee:

Thank you for the opportunity to testify on HB 1373, which would direct the transfer of certain parcels of land, one of which is occupied by Leahi Hospital, from the University of Hawai'i (UH) to the Hawai'i Health Systems Corporation (HHSC) and establish a working group to formulate a plan for the transfer. UH is open to discussion with HHSC, the Department of Health (DOH), and other stakeholders regarding these lands and would be happy to participate in a working group for this purpose. However, UH does not believe that it is appropriate to mandate land transfers before such discussion has taken place, and is strongly opposed to any transfer of one of the parcels adjacent to Leahi Hospital. UH therefore opposes the bill in its current form.

Initially, we note that the bill's reference to four parcels is unclear. UH currently owns six parcels in the area addressed by the bill, as shown on the attached map. Parcel A, which is occupied by Leahi Hospital, is leased to HHSC under a 25 year lease expiring in 2027. Parcel 2, which is adjacent to Parcel A on Kilauea Avenue, is leased to the Department of Health until 2041 and occupied by the Diamond Head Health Center. Parcel B and Parcels 3 and 4 are located across Kilauea Avenue from Leahi Hospital on either side of Sunset Avenue. These parcels are currently occupied and used by DOH and HHSC but do not have ground leases from the University. Finally, Parcel 1 is a vacant parcel adjacent to Leahi Hospital along Makapu'u Avenue, across from the Kapi'olani Community College (KCC) campus, and currently used in part as a gravel parking area. Parcels A and B are held by UH under Executive Order, and Parcels 1, 2, 3, and 4 were acquired by UH through eminent domain.

Parcel 1 is included in KCC's Long Range Development Plan for future classrooms and other campus use. KCC serves over 7500 students and is UH's largest community community college by enrollment. UH is strongly opposed to any transfer of Parcel 1, as KCC's current campus offers little other potential for expansion to serve future enrollment.

UH is open to discussion regarding the other five parcels. KCC currently uses some space at Leahi Hospital for educational purposes, and there have been productive discussions regarding additional opportunities for collaboration. Those opportunities should be part of the discussion, as should opportunities for mutually beneficial land swaps involving other lands currently controlled by DOH or HHSC.

UH notes that HHSC had previously scheduled a meeting with UH leadership in July, 2013, to discuss HHSC's interest in acquiring the Leahi Hospital site. That meeting was canceled when HHSC's then-CEO was terminated and was never rescheduled. UH would be happy to resume direct conversations with leadership of HHSC and DOH at any time regarding these matters. Such discussion may be more efficient than enactment of legislation and subsequent appointment of a formal working group.

For these reasons, UH <u>opposes</u> HB 1373 in its current form and asks that the measure either be amended to delete language mandating land transfer and provide only for the formation of a working group, or held pending further discussion among HHSC, DOH, and UH.
