Testimony Strongly Opposed to HB1515 House Energy and Environmental Protection Committee Tuesday February 17th, 8:30 AM



Aloha Honorable Chair Lee, Vice Chair Lowen and Committee Members,

EEP is the watchdog committee to assure that legislation not in the best interest of SUSTAINABILITY and the ENVIRONMENT does not get passed in the interest of our Islands and the generations to come.

The proposal by Pelatron does not meet the criteria for being sustainable - it is yet another "pipe dream" designed to make people think that there approach will solve all our problems. It Doesn't!

Environmentally the State has made a commitment to waste reduction by 70% with the pledges made in the ALOHA + Challenge. The only way that this desirable goal can be achieved is through processes embedded in the philosophy of Zero Waste where we focus on reduction (both of wasteful consumption AND smarter purchases and packaging), Reuse, Recycling, Repairing durable goods, and deconstruction and salvage. If we can achieve, or even come close to the 70% Goal we will be moving toward the SUSTAINABILITY envisioned in the Aloha + Challenge.

The Pelatron business model takes us in the opposite direction. We would lose the valuable resources we capture through recycling (many recyclable products also contain the most energy - with recycling we preserve that energy - through thermal conversion we lose it!) and the energy provided in the processes is not as efficient nor as clean as many of the resources we are currently using. I highly doubt they would be able to provide energy as inexpensive as the renewables we have coming on-line - the PUC would be hard pressed to approve a more expensive contract that is less environmentally desired than the options we currently have.

ZWK opposes this type of legislation in general. We feel that financial support should not be provided to one vendor over another, especially when the proposed projects are currently part of County solicitations for waste management solutions.

If anything, if funding is to be made available for waste management solutions, it should be available for all proposals, especially those that focus on sustainable solutions rather than the destruction of valuable natural resources.

Also, in the case of Pelatron, we are particularly critical of support for a system with no proven track record and that proposes a totally unrealistic "free" solution. Granting access to State backed Revenue Bonds can be seen as State support for unsustainable, ill conceived, poorly thought out, and un-economical endeavors.

If a proposal seems "Too good to be True", it probably is! With a Pelatron business model we can waste precious resources, pay more for electricity that is less environmentally friendly, provide fewer jobs than focusing on Zero Waste, and take a financial risk with tax payers money. ZWK STRONGLY OPPOSES providing environmentally unsound incentives to businesses.

The Hawai'i Construction Alliance is in **strong support of HB1515**, authorizing the issuance of special purpose revenue bonds to assist Pelatron Q, LLC.

The Hawai'i Construction Alliance is comprised of the Hawai'i Regional Council of Carpenters; the Operative Plasterers' and Cement Masons' Union, Local 630; International Union of Bricklayers & Allied Craftworkers, Local 1; the Laborers' International Union of North America, Local 368; and the Operating Engineers, Local Union No. 3. The construction of a waste-to-energy plant in Kekaha would provide our Kaua'i-based members the opportunity to put their skills to work at home on the Garden Isle.

Aloha Chair Lee, Vice Chair Lowen, and Honorable Representatives:

Pelatron Q **STRONGLY SUPPORTS** the passage of House Bill No. 1515, authorizing the issuance of special purpose revenue bonds to assist Pelatron Q, LLC with the development of waste-to-energy power plants in Hawaii.

Pelatron Q is a joint venture between Pelatron Power Evolution and Solena Q, a partnership that is developing applications of the patented Solena plasma gasification and vitrification (SPGV) process in the State of Hawaii with various public and private partners. This cutting edge integration is more efficient than any biomass conversion technology on the market today. By utilizing state of the art plasma torches in a closed loop and oxygen-deprived environment, SPGV technology extracts more than 99% of all carbon in the waste stream and converts all organic materials into a bio-synthetic gas. This clean gas can be used for everything from generating electricity to making jet fuel.

Different from H-Power and other systems that *burn* trash, our integration eliminates ash and toxins as by products and with as much as four times the net energy output. Most importantly, the renewable energy which we produce is base load and dispatch power that is cheaper to make than using imported oil or liquefied natural gas. This results in an avoided cost of power generation that can be passed on to the consumer.

Currently, the firm is actively cultivating solutions on Kaua'i and O'ahu. The success of these systems will move the State closer to our goals of 70% renewable by 2030, create local ownership and control over power production, generate new jobs for Hawaii's residents, and contribute to our overall economic and environmental independence as an Island State.

Good morning Agriculture Committee Chair Clift Tsuji, Vice Chair Richard Onishi and members of the committee,

My name is HC "Skip" Bittenbender, I am a resident of St. Louis Drive , Honolulu and I strongly oppose HB1514.

My opposition is related to my experience with the growing, processing and marketing of coffee, cacao, macadamia, guava, and 'awa in Hawaii. My experience is based on my job as extension specialist in CTAHR at UHM for the past 29 years. This is my personal testimony and not the official position of the University of Hawaii.

This bill unfairly targets farmers for using legally approved pesticides without demonstrating that farmers have caused problem in our communities. The manufacture, testing, and application of pesticides is highly regulated by the federal and state governemtn departments working together.

My concern is that this legislation is more about harassment of large farms and the seed industry and not public safety as demonstrated by the Hawaii Department of Health finding that more pesticides in urban Honolulu compared to agricultural areas throughout the State.

Please do not pass this bill rather strength the HDOA's resources to enforce and educate Hawaii's farmers and public in general about safe pesticide usage.
