SUBJECT: H.B. 1578, RELATING TO THEFT

My name is Lisa Wond and I support H.B. 1578.

Last June, thieves broke into the gravesite of my grandfather, my grandmother, my aunt and my uncle, and stole their urns. The thieves took the urns to Reynolds Recycling, and received \$31. For them, it was a way to make money.

For our family, it was heartbreaking. Our family canvassed the graveyard and surrounding areas, but the ashes of my family members were never recovered. My hardworking grandparents came to Hawaii a century ago, to build a better life for themselves. They raised ten children, all law-biding, taxpaying, and contributing members of our communities. Our family is on its fifth generation, and numbers nearly 100. In Hawaii, where we respect our elders and our ancestors, what the thieves did to our family was unbelievable.

For us, they stole much more than the urns and ashes of our loved ones. We mourn for a second time the loss of our family members. My mom has had many sleepless nights over the loss of her parents' ashes and what we thought was their final resting place. We are unable to continue our family's culture and tradition of taking our children and grandchildren to visit our family gravesite, knowing that it lies empty. I feel violated and angry that anyone could commit such desperate and selfish acts against us, for \$31.

It is a sad statement of our society when we have to enact laws to prevent people from stealing the urns of dead people. But I fully support this bill, with the hope that it will deter thieves enough to prevent other families from going through what we are enduring.
