TESTIMONY OF THE

TO THE HOUSE COMMITTEE ON JUDICIARY

ON HOUSE BILL NO. 1651

RELATING TO CLASS C FELONIES

February 2, 2016

Chair Rhoads and members of the House Committee on Judiciary, thank you for the opportunity to testify in support of House Bill No. 1651. The purpose of this bill is to increase the fine associated with providing false information in relation to a same day voter registration application from \$1,000 to \$10,000.

Currently, the law provides that the provision of false information in relation to a same day voter registration application will constitute a class C felony. HRS §§ 11-15.2(c)(3) & 15-7(e)(3). A class C felony is normally associated with a fine not exceeding \$10,000 or imprisonment not exceeding five years. HRS §§ 706-640 & 706-660. In order to be consistent with the traditional fine of \$10,000 associated with a class C felony, the bill seeks to amend the fine in advance of the implementation of same day voter registration at absentee walk sites this year.

Common Cause Hawaii supports HB1651 which would increase the fine from \$1,000 to \$10,000 for a person who provides false information when registering to vote late or at an absentee polling place.

While falsifying one's information when registering to vote is already considered a felony, we believe that increasing the applicable fine will act as a further deterrent toward individuals who are considering provide false information on his or her voter registration affidavit.
