SUBJECT: HB 1757 – Relating to Health

The State Council on Developmental Disabilities (DD) **SUPPORTS THE INTENT OF HB 1757**. The bill authorizes a pharmacy to provide a customized patient medication package to any patient of an institutional facility or any member of the general public, subject to certain conditions.

Medication administration can be very complicated, especially when it involves multiple solid oral dosage forms. According to a report done in 2011 by the Centers for Disease Control, there was one death every 19 minutes due to unintentional drug overdose in the United States. Currently, in Hawaii, only individuals residing in an institution may receive medications that are in customized packaging for single dose, decreasing the chance of an unintentional medication overdose.

The Council respectfully asks for your consideration to amend the bill as follows: Page 1, Section 1, line 9: Add "<u>patient's guardian,"</u> after patient's caregiver to read, "<u>The</u> <u>pharmacy has obtained the written consent of the patient, patient's caregiver, patient's</u> <u>guardian, or prescribing practioner; and</u>". There will be situations where the patient is not their own guardian and therefore, would not be able to provide written consent for a pharmacy to provide the customized patient medication packaging. Adding "patient's guardian would address these situations.

Customized patient medication packaging that is prepared by a pharmacist for a specific patient and that contains one or more prescribed solid oral dosage forms would enable individuals with DD who require personal assistance in taking their medication to become less dependent on their assistance. By having customized packaging, they could learn to take their medication independently with less risk of over dosage.

TO THE HONORABLE DELLA AU BELATTI, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Lee Ann Teshima, Executive Officer for the Board of Pharmacy ("Board"). I appreciate the opportunity to testify on House Bill No. 1757, Relating to Health, which would allow a pharmacy to dispense customized patient medication packages to patients in an institutional facility or to the general public pursuant to the consent of the patient, patient's caregiver, or prescribing practitioner and a valid prescription.

The Board has not had an opportunity to review this bill or discuss the proposed amendments as this matter has not yet been a topic of board discussion. The Board will be discussing this measure at their next scheduled meeting on February 25, 2016.

If the intent of the bill is to enable pharmacies to provide medication packages, the committee may wish to consider replacing the term "practitioner" on page 2 line 6 of the bill with the term "registered pharmacist", since the term "practitioner" refers to the individual that prescribes the drugs and "registered pharmacist" refers to the person licensed to practice in a pharmacy.
