They do not have enforcement authority, therefore, they could not ticket individuals for violations that may occur and their duties are limited to their areas of responsibility on a daily basis. RE: HB 1860 RELATING TO THE COUNTIES

The Hawaiian Lifeguard Association (HLA) is the non profit organization that supports the efforts of the counties' 450 professional ocean safety officers in their efforts to reduce drownings and aquatic injury in the State of Hawaii through public education and prevention programs.

As you may know, professional water safety officers in Hawaii are employed by the respective counties (the State of Hawaii does not have a lifeguard service), and are tasked with protecting the millions of visitors and residents who frequent our world famous beaches and the ocean waters adjacent to them. Lifeguards are highly trained and experienced professionals who are the front line of public safety at our beaches. One only has to recall the activities during the past month that included search and rescue operations following the military helicopter incident over ocean waters off Haleiwa, and the prevention and rescue responses during the huge surf that all islands experienced during the past two weeks.

Lifeguards in Hawaii are recognized both nationally and internationally as leaders in the aquatic safety profession. Hawaiian lifeguards pioneered the use of personal watercraft (jet skis) in big surf and have shared their expertise by training other lifeguards and military personnel around the world.

The Hawaiian Lifeguard Association strongly opposes HB 1860, as it proposes to increase the responsibilities of our ocean lifeguards by adding enforcement duties to their already extremely challenging job requirements. The State of Hawaii, DLNR's Division of Conservation and Enforcement (DOCARE) is currently tasked with enforcing the rules and regulations described in HB 1860.

H.B. 1860 - RELATING TO COUNTIES

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO opposes H.B. 1860, which would allow county lifeguards to enforce state laws, rules and regulations in the near shore zone. The bill claims that the state has insufficient staff to regularly provide enforcement of state laws in this zone. However, the counties have limited resources in terms of equipment and staffing to perform this function.

The answer to this problem is to provide additional personnel within the Department of Land and Natural Resources to enforce state laws, not to require the counties to assume these responsibilities that are more appropriately assigned to the state.
