TESTIMONY OF JOBIE M. K. MASAGATANI, CHAIRMAN HAWAIIAN HOMES COMMISSION BEFORE THE HOUSE COMMITTEE ON OCEAN, MARINE RESOURCES, & HAWAIIAN AFFAIRS IN STRONG SUPPORT OF

HB 1932 RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS

February 17, 2016

Aloha Chair Ing and members of the Committee:

The Department of Hawaiian Home Lands (DHHL) is a unique agency as it is the only department explicitly identified in the Hawaii State Constitution as being guaranteed a level of funding. As required by the Admissions Act and as a compact with the United States, the State of Hawaii and the people of Hawaii adopted the Act as a provision of the State Constitution and agreed to faithfully carry out the spirit of the Act for the rehabilitation of the Hawaiian race. These trust responsibilities still remain.

Article XII, Section 1, as noted in the bill, requires the legislature to make sufficient sums available for lot development, loans, rehabilitation projects, and the administration and operating budget of the department. HB 1932, and its companion SB 3029, are historic bills because for the first time in 37 years since the 1978 State Constitutional amendment to Article XII, these legislative measures appropriate sufficient general funding to DHHL to cover the department's administrative and operating expenses for fiscal year 2016-17. This bill creates an opportunity to improve our delivery of beneficiary services, relieves reliance of DHHL on revenues generated on trust lands so that those funds may be used to provide direct benefits to its beneficiaries that is direly needed, and resolves a controversial issue that is long overdue.

In line with Judge Castagnetti's order, DHHL on behalf of its Commission, request that a new paragraph be added to appropriate \$28 million or so much out of general revenues as may be necessary to reimburse DHHL administrative and operating costs expensed by DHHL special and trust funds for fiscal year 2016. We further recommend that the general funds be deposited to the Hawaiian Home Administration Account to facilitate reimbursement of administrative and operating expenses paid by DHHL's special and trust funds.

Pana'ewa is humbled with this opportunity to share our hopes and dreams with the rehabilitative growth in social and economical condition on the homesteads by the passing of this measure.

The Nelson case was all about the lack of funding to DHHL even from its inception (1960) in financial support but was at the discretion of the legislation up until 1978, then in 1979 the people ask for change to which the legislature created this rule; "(3) the rehabilitation of projects to include, but not limited to, education, economic, political, social and cultural processes by which the general welfare and conditions of native Hawaiians are thereby improved. The administration and operating budget of the department of Hawaiian home lands; in furtherance of (3) herein, by appropriated the same in the manner provided by law", still funding failed to reach DHHL's operating provision, all the while the waitlist increased exponentially.

The courts reminded the state of its obligation to DHHL with its provision(s) to the trust which includes the administrative operative condition but will this legislative body acquiesce to the ruling of the state's highest court. The conventional wisdom here is to support these provisions but more so to acquiesce to the constitution mandate on its agreed compact and Admission Act of 59'.

Aloha mai kākou,

The Kalihi Palama Hawaiian Civic Club supports HB 1932. The purpose of this measure is to ensure the legislature fulfills its responsibility under Article XII, Section 1, of the State Constitution by appropriating sufficient general funds for the administration and operating expenses of the Department of Hawaiian Homes Lands (DHHL) for fiscal year 2016-2017.

We support this measure to assure that the Dept of Hawaiian Homelands has sufficient general funds for the administration and operating expenses of the DHHL for fiscal year 2016-2017.

On November 27, 2015, the circuit court of the first circuit of the State of Hawaii issued its Findings of Fact, Conclusions of Law, and Order in *Nelson v. Hawaiian Homes Comm'n*, Civil No. 07-1-1663-083. The circuit court found that since 1978, the legislature has not appropriated enough general funds to pay for the Department of Hawaiian Home Lands' administrative and operating expenses. The circuit court noted that the legislature appropriated \$9,632,000 in general funds to the Department of Hawaiian Home Lands for administrative and operating expenses for fiscal year 2015–2016, which was less than the department's request for \$28,478,966 in general funds. The court determined that the Department of Hawaiian Home Lands "suffers from a lack of funding..., which adversely affects beneficiaries of the Hawaiian Home Lands Trust," and declared that the legislature is constitutionally obligated to appropriate "more than \$28 million for fiscal year 2015–16" in general funds for the Department of Hawaiian home lands' administrative and operating budget.

The court gave opportunity for the State to defend its decision to appropriate \$9,632,000, which is significantly less than the \$28,478,966 substantiated by the DHHL. Clearly, this kind of deep reduction in the budget requested by DHHL can only have adverse consequences. We recall the many criticisms about the Dept of Hawaiian Home Lands published over a series of articles in the Star Advertiser. How can we expect the DHHL to fix any shortcomings if we don't sufficiently fund their administrative and operating expenses? We urge the legislature to heed the decision of the Court and to provide more reasonable sufficient funds to DHHL for fiscal year 2016-2017 to enable the Department to carry out its mission. Failing to do so will adversely affect its ability to carry out its mission.

Aloha Chairman Ing, vice chair Lowen and members of the House OMH committee. I am Annelle Amaral, president of the Association of Hawaiian Civic Clubs (AHCC), unable to be at the hearing today due to my status as a delegate to the Native Hawaiian `Aha. AHCC supports this bill.

The AHCC consists of sixty seven component clubs throughout Hawaii and sixteen states on the continent. A number of our members are also homesteaders and we have heard their frustration over the years regarding inadequate funding from the State to fulfill the mission of the Department. As a function of our annual conventions we deliberate Native Hawaiian issues submitted by our clubs through resolutions that are discussed, voted upon and, if adopted, forwarded to the legislation.

Resolutions with regard to fair and adequate funding for DHHL have been deliberated and adopted several times so this is not a new issue for us. What is new is the suit and court judgement that lays the State problem squarely at the legislature's door. State government has taken advantage of the Department of Hawaiian Homes for too many years, ignoring the constitutional mandate to provide appropriate funding by controlling the administrative and commission appointments.

TESTIMONY IN OPPOSITION

1. The Attorney General of the State of Hawaii has stated that he is filing an appeal of the Circuit Court order that the legislature must appropriate "more than \$28 million for fiscal year 2015-16" in general funds for the department of Hawaiian Home Lands' administrative and operating budget. There are serious questions which must be litigated, regarding whether it is a violation of the separation of powers for a judge to order the legislature to pass such a bill. The legislature has a fiduciary obligation to the taxpayers to protect the public fisc against unreasonable or illegal demands. The legislature should wait for the legal process to conclude, and not act rashly or prematurely.

2. The Office of Hawaiian Affairs has \$650 Million in assets, including \$350 Million in its investment portfolio. All that wealth is supposed to be used for "the betterment of native Hawaiians as defined in the Hawaiian Homes Commission Act of 1920." OHA should pay in full however much money is owed to DHHL, both arrears and in future. If OHA will not do what is pono on its own initiative, then the legislature should pass a bill transferring the funds from OHA to DHHL. The legislature often "raids" trust funds such as the Hurricane Fund or the Highway Fund to balance the budget. OHA is an agency of the State government and therefore falls under the budget and appropriation authority of the legislature.

Aloha Chair Ching and Vice Chair Lowen:

My name is Homelani Schaedel, a beneficiary of the Hawaiian Home Commission Act. I am blessed to live on homestead lands in Kapolei.

"I do solemnly swear that I will support and defend the Constitution of the United States, and the Constitution of the State of Hawaii, and that I will faithfully discharge my duties......to the best of my ability".

This is the oath each member of both houses repeat on Opening day of the Legislature.

The Constitution of the United States is the central instrument of American government and the supreme law of the land, and so to, is the Constitution of the State of Hawaii.

This bill acknowledges that the Legislature has failed to uphold the Hawaii State Constitution, Article 16 Section 7, Article 12 Sections 1 and 2, and Section 101 of the Hawaiian Homes Commission Act, as amended in 1920 for decades, which prompted plaintiffs in the Nelson case to file suit against the State and the Hawaiian Homes Commission.

I find it ironic that legislators are often referred to as "lawmakers", that the bills passed by the Legislature becomes law; and that the Legislature expects the Judicial arm of our government to implement and/or enforce these laws.

Yet, when the Judicial arm of our state government holds the Legislature responsible and accountable to the Constitution of our state, the Legislature deems it appropriate to assert its' powers to circumvent the law.

The leadership in both houses unilaterally determined the Judiciary arm of our government overstepped its authority and directed the Attorney General to file a motion to appeal the courts' decision on the Nelson case, **and** decided to secure the services of outside counsel without consulting with its members within the required timeframe, thereby violating their own rules.

Language in the Constitution of the State of Hawaii Article 12 Section 1 is concise and clear, "The Legislature shall make sufficient sums available for (4) the administration and operating budget of the department of Hawaiian home lands".

Why must the Department of Hawaiian Home Lands on behalf of its' beneficiaries have to beg for what is constitutionally mandated? WHY? A'ole loa! A'ole pono!

Those in both houses who continue to resist fulfilling the obligation of this legislature and the people of this state to the Department of Hawaiian Home Lands and its' beneficiaries need to go outside of this building and read the inscription on the State's seal. Instead of perpetuating righteousness, they perpetuate indifference and immorality!

It is blatantly clear that we Hawaiians have few supporters in this legislature, and the indignation we feel is justified! The legislatures' political dissidence continues to plague our people. Legislators who feel the passivity of our people support their impropriety and disregard of the law; are negligent in their duty to the beneficiaries of the Department of Hawaiian Home Lands.

While I don't understand why another law must be enacted "to ensure the legislature fulfills its responsibility"... to an existing law? I mahalo all the introducers of this bill and its' companion in the senate for their courage. Many Hawaiian homestead leaders know the challenge they faced from their leadership and colleagues. We will not forget your dedication and commitment to uphold the oath sworn by all members of both houses, by introducing this bill.

I strongly support an amendment to the language of this bill to include that "the Legislature appropriate the amount ordered by the court to the Department of Hawaiian Home Lands 2015–16 budget in the amount of \$28, 478, 966.00 from general funds and dropping their appeal. In its' current version, I support this bill with reservations.

In closing, I want this committee to know that while there are 76 members in both houses; there are hundreds of homestead leaders and volunteers across this state in partnership with the Department of Hawaiian Home Lands, other agencies and, organizations who work countless hours to serve our people. Some of us with little or no experience are building community and health centers. We respond to and help resolve individual issues, work on multiple community projects, attend countless meetings, workshops, training, and like today we are here advocating for the very same beneficiaries you swore to serve.

You need to stop the Department of Hawaiian Home Lands from having to rob Peter to pay Paul to keep their doors open. By annually appropriating sufficient funds for their administrative and operating budget; they can then focus on their goals to increase delivery of homes and improve service to their beneficiaries.

Comments: This is a constitutional issue and the Governor and Legislators are required to fulfill their oath to carry out the duties of the Constitution. The State needs to "sufficiently" fund the DHHL for admin & operating expenses from the State's General Funds in the amount of more than \$28.4 million. For too long the State has allowed the department to fund themselves from DHHL trust funds and this needs to stop now. The State funds all other State and even some non-State agencies like HTA with general funds. Legislators need to fund more than \$28.4 million as directed by Judge Castagnetti because the State has failed to do it themselves. House Bill No. 1932 Relating to the Department of Hawaiian Home Lands

Aloha Chair Ing, Vice Chair Lowen and Members of the Committee:

The Ka Lāhui Hawai'i Political Action Committee (KPAC) affirms and defends our Hawaiian peoples' right to over 1.8 million acres of our national lands.

KPAC submits the following testimony in support of HB 1932. This bill ensures the legislature fulfills its responsibility under Article XII, section 1 of the state constitution by appropriating sufficient general funds for the administration and operating expenses of the Department of Hawaiian Home Lands.

The Hawaiian Homes Commission Act, 1920 (HHCA) enacted by Congress established the Hawaiian Home Lands program. As a condition of Statehood in section 4 of the Admissions Act in 1959, the State is required to adopt the HHCA as a provision of the Constitution. As such Article XII, section 1 of the State Constitution adopts the HHCA and further provides that the legislature shall make sufficient sums available for 4 purposes, one of which is the administration and operating budget of DHHL.

This bill is one step in complying with the recent court's decision in the Nelson case that ordered that "the sufficient sums that the legislature is constitutionally obligated to appropriate in general funds for DHHL's administrative and operating budget (not including significant repairs) is more than \$28 million for fiscal year 2015-2016." The legislature appropriated \$9.6 million in general funds for fiscal year 2015-2016. While this bill appropriately funds \$28 million for fiscal year 2016-2017, the legislature must also fund the additional \$18.4 million for the current fiscal year. At a minimum, language should be included in this bill that any special or trust funds used this fiscal year for administrative and operating expenses should be replenished with general funds.

The court's directive is clear in ordering that the State "shall prospectively fulfill their constitutional duties and trust responsibilities" and is "enjoined from violating these obligations."

The court also noted in its ruling that "No other State department has a constitutional mandate requiring the legislature to provide 'sufficient sums' for its administrative and operating budget." Given the contractual agreement as part of Statehood and the constitutional mandate, funding DHHL must be supported despite the pending notice of appeal filed by the Attorney General. Thus, KPAC requests this bill be passed and additional funding be appropriated for this fiscal year.

Over the years our family has grown in size, 4 generations deep of Native Hawaiian with 50% blood quantum. As I'm the current lessee of this property that I hold dear, I also house 3 other household members and their Ohana. Our home is now over crowned and I'm looking at other ways to make this house, that is now 60 years old, comfortable for all.

What this bills means to us, OPPORTUNITY!

As I have worked closely with the Department of Hawaiian Home Lands and Hawaiian Homes Commissioners, I've come to notice things that other Native Hawaiian Lessee and applicant don't know about the funding source and how the department survive on a small or limited budget. <u>I've found out</u> that it's the KULEANA of this legislation and State of Hawaii to fund this department.

Over the years – 13 to count, the Department of Hawaiian Home Lands has not received any funds from State of Hawaii up until last year. I feel that we are being discriminated against, because DHHL isn't being funded by this government that we pay taxes too. How can you deny Native Hawaiian who live here in Hawaii and pay taxes to help run our government but deny access to funding our Ali`I Trust who will assistance those who are waiting for their `Aina to live on. Furthermore, it's becoming more expense to live on our Native Lands.

We deserve this settlement of 28 million that was found in favor of our trust back in November 2015. This settlement will help the department with their operation and administrative cost, helpful giving opportunity to qualified Native Hawaiians job OPPORTUNITY OR CONTRACTS. I can only see great opportunity for us service provides to continue great work in our Hawaiian Community. CNHA continues to work with homestead associations with a focus on understanding DHHL's budget because we are firm believers that homestead community leaders are the best partners to support DHHL in fulfilling its mission to return Hawaiians to their lands.
