Chair Morikawa and Members of the Committee:

The Department of the Attorney General provides the following comments.

The purpose of the bill is to appropriate \$1 for fiscal year 2016-2017 to the Department of Human Services (DHS) to develop prevention and intervention programs to target youth who are at high risk of engaging in gang activities or of joining youth gangs.

Article III, section 14 of the Hawaii Constitution provides in part: "No law shall be passed except by bill. Each law shall embrace but one subject, which shall be expressed in its title...." The title of this bill, "Relating to youth gang prevention and intervention," arguably expresses two subjects—youth gang prevention and youth gang intervention. Indeed, the bill requires the DHS to develop programs that both help prevent youth from joining gangs and help intervene in the lives of youth who engage in gang activities. Because the bill appears to include two subjects in its title, the bill may be subject to challenge as violative of article III, section 14, of the Hawaii Constitution. We suggest this problem could be cured by providing an explanation in section 1 as to why "prevention and intervention" actually constitute a single subject. If this explanation cannot be made and there are really two subjects, we recommend that another vehicle with a title such as "Relating to Youth Gangs" or "Relating to Human Services" be used to enact the appropriation proposed by this bill.

We respectfully ask the Committee to make the suggested amendments or to hold this bill.

**OFFICE'S POSITION:** OYS supports the intent of the measure but requests that any approrpriation not affect the priorirties in the Executive Biennium Budget. OYS agrees that many factors can contribute toward an apparent increase in graffiti, violence, substance abuse and criminal activities, including risk factors such as poverty, higher concentrations of immigration, lack of parental guidance and supervision, and social disorganization in the community. Careful anaylsis of the extent and depth of the type of criminal activity, and symptoms of underlying social and economic dynamics is required prior to committing valuable resources toward any initiative related to our State's at-risk and troubled youth.

OYS supports a balanced and multi-prong approach to strengthen and improve a community's response in addressing any problem affecting a community. Currently, prevention and intervention efforts are underway through ongoing partnerships with various resources such as the police, Department of Education, Judicary, community-based agencies, and the University of Hawaii, to address problems such as increased criminal activities that may be more related to ethnic and geographic concerns rather than a strict definition of gang activity.

**PURPOSE**: The purpose of the measure is to appropriate funds to target youths who live ain public housing who are at risk of engaging in gang activites or joining gangs.

### **RE: H.B. 1986; RELATING TO YOUTH GANG PREVENTION AND INTERVENTION.**

Chair Morikawa, Vice-Chair Kobayashi and members of the House Committee on Human Services, the Department of the Prosecuting Attorney of the City and County of Honolulu ("Department") supports the intent of H.B. 1986, however, would urge this committee to consider reallocating the funds associated with H.B. 1986 to Adult Friends for Youth as an alternative agency to carry out the goals and objectives.

The purpose of H.B. 1986 is to help reduce the growing youth gang problem in the State by creating programs aimed to promote education, self-esteem, individual growth and development, leadership, and responsibility. The creation of additional programs to assist our youth is consistent with this Department's ongoing concern for at-risk youth and the rise of youth gang affiliation. Over the years, our Department has seen increases in crime involving youth offenders who at times are as young as 12 years of age. Yet, despite this rise, there are few programs available to youth offenders in Hawaii, often leaving them with little or no meaningful alternatives.

While the purpose of H.B. 1986 is to establish a multi-pronged approach in programs which aim to target at-risk youth who reside in the public housing, our Department would strongly urge this committee to consider appropriating funds associated with H.B. 1986 for the fiscal year 2016-2017 to Adult Friends for Youth as an alternative. Adult Friends for Youth, was established in 1985 at the University of Hawaii, School of Social Work and boasts a stellar track record and history of sustainability which would ensure that any appropriated funds will be allocated properly and effectively. Adult Friends for Youth works with more than 400 high risk youth per week and has established many successful programs such as their Re-directional Therapy which is an effective therapeutic approach to combat violence, drugs, crime, teen pregnancy, family dysfunction, learning disabilities and anti-social behaviors amount the very

high risk youth both in and outside of the classroom. Through the programs implemented by Adult Friends for Youth, their services have successfully changed the attitudes and behaviors of over numerous different gangs. They have also successfully assisted multiple gang members through the difficult task of integration back into the community.

For all the reasons above, the Department of the Prosecuting Attorney of the City and County of Honolulu supports the intent of H.B. 1986 and strongly urges this committee to reallocate any funds to the Adult Friends for Youth Program. Thank you for the opportunity to testify on this matter.

Aloha Mai Keia Kakahiaka kakou, Madam Chair and members of the House Human Services Committee. I stand in strong support of HB 1986.

As the convenor of the Kalihi Community Youth Violence and Gang Prevention and Intervention Task Group, I want to relay our concerns for the growing incidences of youth violence in our communities and neighborhoods. We have seen and heard reports about a proliferation of violence on school campuses, parks, housing complex', fast food establishments and almost all public places that youth gather. These fights, that some refer to as gang fights, occur quickly as young people use the latest communication devices to spread the word which allow them to gather and disperse very quickly.

Kalihi is a melting pot of diverse cultures and ethnicities where many young immigrants and families get their start. The socio-economic factors that are woven throughout the community lead many young people feeling isolated and even excluded from the mainstream cultures as well as academic and economic successes. It's unfortunate but there is de facto segregation by ethnicity and socio-economic factors that are not intentional but create a community of youth faced with alienation caused by lack of opportunity to join the mainstream culture. Thus, the so called gangs are centered on territorial identities and ethnic similarities as their source of pride.

Kalihi is also like the canaries in the mine and the problems that face our community serve as indicators of more ominous problems we face statewide with our youth. The Task Group members recognize the importance and effectiveness of prevention and intervention strategies that provide programs and activities that

keep youth out of the judicial system and the costly alternatives of rehabilitation and treatment.

I want to encourage our legislators to look to youth programs and services that give Recommendations include mobilizing the community to eradicate graffiti, provide multi-lingual information videos and pamphlets for parents and guardians to enable them to spot problems in their children and providing the referral to agencies and organizations that can help families. At one time most of the Public Housing project had resources to conduct social and recreation program within their complex'. But many expressed doubts about whether it was the role of public housing to implement these programs. Some even felt it was promoting segregation for those youth who reside in public housing. But like programs that accommodate students with special needs in our schools, we also need to consider programs that address the needs and conditions of youth who reside in public housing.

I urge you to pass this measure and refer it to the Finance Committee with a strong recommendation for funding. Mahalo!

Gangs do not only reside in public housing it has become an Island wide problem. The use of technology via social media has had a far reaching impact on Oahu. We have seen gangs gravitate to Kalihi from as far West (including Waianae, Nanakuli, Kapolei, and Waipahu) and as far East (including Aina Haina, Waimanalo, Kaimuki, etc...) We have also witnessed youth from the North Shore engaging in gang activities. Believe it or not, many communities and public schools are affected by this wide spread problem. To limit funding or services to public housing would be tragic and not allow services to address the larger problem.
